# Functionals of fractional Brownian motion and the three arcsine laws

#### Abstract

Fractional Brownian motion is a non-Markovian Gaussian process indexed by the Hurst exponent $H \in[0,1]$, generalizing standard Brownian motion to account for anomalous diffusion. Functionals of this process are important for practical applications as a standard reference point for non-equilibrium dynamics. We describe a perturbation expansion allowing us to evaluate many non-trivial observables analytically: We generalize the celebrated three arcsine-laws of standard Brownian motion. The functionals are: (i) the fraction of time the process remains positive, (ii) the time when the process last visits the origin, and (iii) the time when it achieves its maximum (or minimum). We derive expressions for the probability of these three functionals as an expansion in $\varepsilon=H-\frac{1}{2}$, up to second order. We find that the three probabilities are different, except for $H=\frac{1}{2}$ where they coincide. Our results are confirmed to high precision by numerical simulations.

## I. INTRODUCTION

## A. Fractional Brownian motion

In the theory of stochastic processes fractional Brownian motion ( fBm ) plays as important a role as standard Brownian motion [1-4]. It was introduced [5, 6] to incorporate anomalous diffusive transport [7], which is abundant in nature, but not describable by standard Brownian motion. FBm has several key mathematical structures to qualify it as the most fundamental stochastic process for anomalous diffusion: translation invariance in both time and space (stationarity), invariance under rescaling, and Gaussianity [8]. The current mathematical formulation of fBm was given by Mandelbrot and Van Ness [6] to describe correlated time-series in natural processes. It is defined as a Gaussian stochastic process $X_{t}$ with $X_{0}=0$, mean $\left\langle X_{t}\right\rangle=0$ and covariance

\begin{equation*}
\left\langle X_{t} X_{s}\right\rangle=t^{2 H}+s^{2 H}-|t-s|^{2 H} \tag{1}
\end{equation*}
$$

The parameter $H \in(0,1)$ is the Hurst exponent. An example is given in Fig. 1. Standard Brownian motion corresponds to $H=\frac{1}{2}$ where the covariance reduces to $\left\langle X_{t} X_{s}\right\rangle=$ $2 \min (s, t)$.

FBm is important as it successfully models a variety of natural processes [1, 2]: A tagged particle in single-file diffusion ( $H=0.25$ ) [9-13], the integrated current in diffusive transport $(H=0.25)$ [14], polymer translocation through a narrow pore $(H \simeq 0.4)$ [15-17], anomalous diffusion [18], values of the $\log$ return of a stock ( $H \simeq 0.6$ to 0.8 ) [19-22], hydrology ( $H \simeq 0.72$ to 0.87 ) [23, 24], a tagged monomer in a polymer chain $(H=0.25)$ [25], solar flare activity ( $H \simeq 0.57$ to 0.86 ) [26], the price of electricity in a liberated market ( $H \simeq 0.41$ ) [27], telecommunication networks ( $H \simeq 0.78$ to 0.86 ) [28], telomeres inside the nucleus of human cells ( $H \simeq 0.18$ to 0.35 ) [29], sub-diffusion of lipid granules in yeast cells [30], and diffusion inside crowded fluids
( $H \simeq 0.4$ ) [31], are few such examples. Due to the simplicity of its definition, fBm has a fundamental importance, as well as a multitude of potential applications. The pressing questions are how the celebrated properties of standard Brownian motion generalize for fBm , and how can one analyze them? In this paper we aim to address some of these questions.

The anomalous diffusion in fBm comes from the longrange correlations in time, which makes the process nonMarkovian, i.e. its increments are not independent, unless $H=\frac{1}{2}$; this can be seen from the correlation of increments,

$$
\begin{equation*}
\left\langle\partial_{t} X_{t} \partial_{s} X_{s}\right\rangle=2 H(2 H-1)|s-t|^{2(H-1)} \tag{2}
\end{equation*}

The positivity of correlations for $H>\frac{1}{2}$ means that the process is correlated and the paths appear to be more regular than for standard Brownian motion. The converse holds for $H<\frac{1}{2}$, where increments are anti-correlated, making the process rough on short scales. This can be seen in Fig. 1 for the sample trajectory of a fBm generated in our computer simulation, using the same random numbers for the Fourier modes, which renders the resulting curves comparable.

The non-Markovian dynamics makes a theoretical analysis of fBm difficult. Until now, few exact results are available in the literature [32-34]. In this paper, we describe a systematic theoretical approach to fBm , by constructing a perturbation theory in

around the Markovian dynamics. We describe this approach with a focus on observables that are functionals of the fBm trajectory $X_{t}$, and thereby depend on the entire history of the process. The fraction of time $X_{t}$ remains positive, the area under $X_{t}$, the position of the last maximum, or the time where $X_{t}$ reaches its maximum are examples of such functionals.

Functionals of stochastic processes are a topic of general interest [35, 36]. Beside their relevance in addressing practical problems, they appear in path-ensemble generalizations

of traditional statistical mechanics [37, 38]. Beyond equilibrium statistical mechanics, the dynamics plays a crucial role in the statistical theory of non-equilibrium systems. Observables that are functionals of a stochastic trajectory, e.g. entropy production, empirical work, integrated current, or activity, are relevant dynamical observables for a thermodynamic description of non-equilibrium systems [39].

The statistics of functionals is non-trivial already for Markovian processes, and is much harder for non-Markovian ones like fBm . In our work, we overcome the inherent difficulty of the non-Markovian dynamics of fBm by using a perturbation expansion around standard Brownian motion ( $H=$ $\frac{1}{2}$ ), which is a Markovian process. This allows us to use many tricks available for Brownian motion, such as the method of images.

## B. The three arcsine laws

We illustrate this approach by considering a generalization of a famous result for standard Brownian motion: the three arcsine-laws [40-43]. This result is about the following three functionals of a Brownian motion $B_{t}$ starting from the origin $B_{0}=0$, and evolving during time $T$ (see Fig. 2):
(i) the total duration $t_{\text {pos }}$ when the process is positive,
(ii) the last time $t_{\text {last }}$ the process visits the origin, and
(iii) the time $t_{\text {max }}$ it achieves its maximum (or minimum).

Remarkably, all three functionals have the same probability distribution as a function of $\vartheta:=t / T$, given by [40-43]

$$
\begin{equation*}
p(\vartheta)=\frac{1}{\pi \sqrt{\vartheta(1-\vartheta)}} \tag{4}
\end{equation*}
$$

As the cumulative distribution contains an arcsine function, these laws are commonly referred to as the first, second, and third arcsine-law. These laws apply quite generally to Markov processes, i.e. processes where the increments are uncorrelated [41]. Their counter-intuitive form with a divergence at $\vartheta=0$ and $\vartheta=1$ has sparked a lot of interest, and they are considered among the most important results for stochastic processes. Recent studies led to many extensions, in constrained Brownian motion [44-46], for general stochastic processes [47-52], and even in higher dimensions [53-55]. The laws are realized in a plethora of real-world examples, from finance [56,57] to competitive team sports [58].

Using our perturbative approach, we show how the three arcsine-laws generalize for fBm . Our results show that unlike for standard Brownian motion, all three functionals have different probability distributions, which coincide only when $\varepsilon=0$, i.e. for Brownian motion. As for two of the laws the difference is first seen at second order in $\varepsilon$, we have to develop the technology beyond what was done at leading order [5966]. Using our perturbation results up to second order, and a scaling ansatz, we propose expressions for all three probability densities. These expressions agree well with our numerical results, even for large values of $\varepsilon$, i.e. including the full range

of Hurst exponents reported in the literature cited above [930]. A short account of our main results was reported in [67].

This article is organized in the following order: In Sec. II we discuss basics of an fBm and introduce the perturbation expansion of the action. As a consistency check we derive the free propagator for an fBm in Sec. III, which is checked against the exact result. In the rest of the sections we discuss the three functionals for the arcsine-law. In Sec. IV, we summarize our main analytical results for the generalization of the arcsine laws for an fBm , and compare them with our numerical simulations. How these results are derived is first sketched in Sec. V, and thoroughly discussed in later sections. Many algebraic details and a description of our numerical algorithm are given in the appendices.

## II. PERTURBATION THEORY

## A. The action to second order in $\varepsilon$

Our analysis is based on a perturbation expansion of the action for an fBm trajectory around standard Brownian motion ( $H=\frac{1}{2}$ ). This expansion was discussed and used earlier in [59-67] at linear order. Here, we give additional details at second order, which is essential to show the difference between the generalizations of the three arcsine-laws.

An ensemble of trajectories for fBm in a time window $[0, T]$ is characterized by the Gaussian action

$$

S\left[X_{t}\right]=\frac{1}{2} \int_{0}^{T} d t_{1} \int_{0}^{T} d t_{2} X_{t_{1}} G\left(t_{1}, t_{2}\right) X_{t_{2}} \tag{5}
\end{equation*}

with covariance $G^{-1}\left(t_{1}, t_{2}\right)=\left\langle X_{t_{1}} X_{t_{2}}\right\rangle$ as given in Eq. (1). The probability of a trajectory, up to a normalization, is given by

$$
\begin{equation*}
P\left[X_{t}\right] \sim e^{-S\left[X_{t}\right]} \tag{6}
\end{equation*}
$$

For $H=\frac{1}{2}$ one recovers the Feynman-Kac formula [68] for standard Brownian motion.

Writing $H=\frac{1}{2}+\varepsilon$ and expanding Eq. (5) in powers of $\varepsilon$ we obtain (a derivation is in App. A)

S=\frac{1}{D}\left[S_{0}-\frac{\varepsilon}{2} S_{1}+\varepsilon^{2} S_{2}+\cdots\right] \tag{7}
\end{equation*}

where

$$
\begin{align*}
S_{0}= & \frac{1}{4} \int_{0}^{T} d t \dot{x}(t)^{2}  \tag{8a}\\
S_{1}= & \int_{0}^{T} d r_{1} \int_{r_{1}+\omega}^{T} d r_{2} \frac{\dot{x}\left(r_{1}\right) \dot{x}\left(r_{2}\right)}{r_{2}-r_{1}}  \tag{8b}\\
S_{2}= & \frac{1}{2} \int_{0}^{T} d r_{1} \int_{r_{1}+\omega}^{T} d r_{2} \dot{x}\left(r_{1}\right) \dot{x}\left(r_{2}\right) \times  \tag{8c}\\
& {\left[\int_{0}^{r_{1}-\omega} \frac{d s}{\left(r_{1}-s\right)\left(r_{2}-s\right)}+\int_{r_{2}+\omega}^{T} \frac{d s}{\left(s-r_{1}\right)\left(s-r_{2}\right)}\right] }

The pre-factor, the diffusion constant, reads

$$
\begin{equation*}
D \equiv D(\varepsilon, \omega)=e^{\varepsilon 2(1+\ln \omega)-\varepsilon^{2} 2\left(1-\frac{\pi^{2}}{6}\right)+\mathcal{O}\left(\varepsilon^{3}\right)} \tag{9}
\end{equation*}
$$

The small-time (ultraviolet) cutoff $\omega>0$ is introduced to regularize the integrals in the action. Our final results are in the limit of $\omega \rightarrow 0$, and independent of $\omega$. The second-order term in the exponential in Eq. (9) is independent of $\omega$, since from dimensional arguments $D \sim \omega^{\varepsilon}$,

Remark: To keep our formulas simple, we explicitly write the ultraviolet cutoff in Eqs. (8b)-(8c) only for integrals which would otherwise diverge.

## B. Integral representation of the action, and normal-ordered form of the weight

For our explicit calculations we use an alternative representation of Eqs. (8b) and (8c):

and

S_{2}=\frac{1}{2} \int_{0}^{\Lambda} d y_{1} \int_{0}^{\Lambda} d y_{2} \int_{0}^{T} d r_{1} \int_{r_{1}}^{T} d r_{2} \dot{x}\left(r_{1}\right) \dot{x}\left(r_{2}\right) \times \\
{\left[\int_{0}^{r_{1}} d s e^{-y_{1}\left(r_{1}-s\right)-y_{2}\left(r_{2}-s\right)}+\right.} \\
\left.\int_{r_{2}}^{T} d s e^{-y_{1}\left(s-r_{1}\right)-y_{2}\left(s-r_{2}\right)}\right] \tag{10b}
\end{gather*}
$$

where the ultraviolet cutoff $\omega$ in time is replaced by an upper limit $\Lambda$ for the $y$ variables. A vanishing $\omega$ is equivalent to $\Lambda \rightarrow \infty$, which is always taken in the final results.

Their relation can be inferred as follows: for small $\omega$

$$
\begin{equation*}
\int_{\omega}^{\infty} \frac{d t}{t} e^{-s t} \simeq-\ln (s \omega)-\gamma_{\mathrm{E}}+\mathcal{O}(\omega) \tag{11}
\end{equation*}
$$

where $\gamma_{\mathrm{E}}=0.57721 \ldots$ is the Euler constant. On the other hand, the integral representation for large $\Lambda$ reads

$$
\begin{equation*}
\int_{0}^{\Lambda} d y \int_{0}^{\infty} d t e^{-t s-t y} \simeq \ln \left(\frac{\Lambda}{s}\right)+\mathcal{O}\left(\Lambda^{-1}\right) \tag{12}
\end{equation*}
$$

Demanding that they agree, we get

$$
\begin{equation*}
\Lambda=\frac{1}{\omega} e^{-\gamma_{\mathrm{E}}} \tag{13}
\end{equation*}
$$

In Sec. III we further check Eq. (13) by constructing the free diffusion propagator for fBm . In terms of $\Lambda$, Eq. (9) reads

$$
\begin{equation*}
D=e^{\varepsilon 2\left(1-\ln \Lambda-\gamma_{\mathrm{E}}\right)-\varepsilon^{2} 2\left(1-\frac{\pi^{2}}{6}\right)+\mathcal{O}\left(\varepsilon^{3}\right)} \tag{14}
\end{equation*}
$$

Remark: Keeping in mind the ultraviolet cutoff $\omega$ present in Eqs. (8b)-(8c), integrals arising from Eq. (10) are interpreted such that

$$
\begin{equation*}
\int_{r_{1}}^{T} d r_{2} \delta\left(r_{2}-r_{1}\right):=\lim _{\omega \rightarrow 0} \int_{r_{1}+\omega}^{T} d r_{2} \delta\left(r_{2}-r_{1}\right)=0 \tag{15}
\end{equation*}
$$

This convention for the expression of the action is used throughout our analysis.

Remark: A subtle point is that at second order for the probability in Eq. (6) one encounters terms of order $S_{1}^{2}$ in which one contracts two of the $\dot{x}$ (contracting all four gives a constant entering into the normalization of the probability, thus ignored),

\frac{1}{4} \int_{r_{3}<r_{1}<r_{2}} & \frac{\dot{x}\left(r_{2}\right)}{r_{2}-r_{1}} \frac{\dot{x}\left(r_{3}\right)}{r_{1}-r_{3}} \\
\frac{1}{4} \int_{r_{1}<r_{2}<r_{4}} & \frac{\dot{x}\left(r_{1}\right)}{r_{2}-r_{1}} \\
\frac{1}{4} \int_{r_{1}, r_{3}<r_{2}\left(r_{4}\right)}^{r_{4}-r_{2}} & \frac{\dot{x}\left(r_{1}\right)}{r_{2}-r_{1}} \frac{\dot{x}\left(r_{3}\right)}{r_{2}-r_{3}} .\end{cases}
\end{aligned}

The cutoffs in the integrations are implicit and the right arrow indicates contraction of a pair of $\dot{x}$. The four terms come, in the given order, from the contraction of $\dot{x}\left(r_{1}\right) \dot{x}\left(r_{3}\right)$, $\dot{x}\left(r_{1}\right) \dot{x}\left(r_{4}\right), \dot{x}\left(r_{2}\right) \dot{x}\left(r_{3}\right)$, and $\dot{x}\left(r_{2}\right) \dot{x}\left(r_{4}\right)$. They have the same structure as those of $S_{2}$ in Eq. (8c), and we can group them together: the first contracted term in Eq. (16) cancels the first term of Eq. (8c), the fourth contracted term in Eq. (16) cancels the last term in Eq. (8c) (note that $S_{2}$ comes with a minus sign in the expansion, and the points $r_{1}$ and $r_{2}$ are ordered); the remaining two contracted terms are identical and can be incorporated into a redefinition of $S_{2}$ as discusses below.

These cancellations make it advantageous to exclude selfcontractions, i.e. the terms on the r.h.s. of Eq. (16), from $e^{-S}$, which in field theory is noted as a normal-ordered [69] weight,

In this normal-ordered form, the second-order term $S_{2}$ is replaced by

$$

\mathcal{S}_{2}^{(\mathrm{n})}=\frac{1}{2} & \int_{0}^{\Lambda} d y_{1} \int_{0}^{\Lambda} d y_{2} \int_{0}^{T} d r_{1} \int_{r_{1}}^{T} d r_{2} \dot{x}\left(r_{1}\right) \dot{x}\left(r_{2}\right) \\
& \times \int_{r_{1}}^{r_{2}} d s e^{-y_{1}\left(r_{1}-s\right)-y_{2}\left(r_{2}-s\right)} \tag{17}

(cutoffs are implicit). Using the normal-ordered weight makes our calculations simple and elegant. However, to keep our calculation accessible for a non-specialist, we present our analysis using the weight in Eq. (10). We shall mention at relevant stages of the calculation which can be simplified using normal ordered weight.

## III. THE FREE FBM PROPAGATOR

In this section, we verify the perturbation expansion in Eqs. (7)-(10) by deriving a known result about the propagator of an fBm . The probability for an fBm , starting at $X_{0}=0$, to be at $X_{T}=m$ at time $T$ is given by

\begin{equation*}
\mathcal{G}_{H}(m, T)=\frac{e^{-\frac{m^{2}}{4 T^{2 H}}}}{\sqrt{4 \pi T^{2 H}}} \tag{18}
\end{equation*}
$$

which is straightforward to see for the Gaussian process with covariance Eq. (1).

In terms of the action in Eq. (5), the same propagator can be expressed as

$$
\begin{equation*}
\mathcal{G}_{H}(m, T)=\frac{W_{H}(m, T)}{N_{T}} \tag{19}
\end{equation*}
$$

where

$$
\begin{equation*}
W_{H}(m, T)=\int_{x(0)=0}^{x(T)=m} \mathcal{D}[x] e^{-S[x]} \tag{20a}
\end{equation*}
$$

and normalization

$$
\begin{equation*}
N_{T}=\int_{-\infty}^{\infty} d m W_{H}(m, T) \tag{20b}
\end{equation*}
$$

Eq. (18) can be derived from Eq. (19) using the perturbation expansion (7). For this, we Taylor expand Eq. (18) in $\varepsilon$ as

& \mathcal{G}_{H}(m, T)= \mathcal{G}(m, T)+\varepsilon 2 T(\ln T) \partial_{m}^{2} \mathcal{G}(m, T)+ \\
& \varepsilon^{2}\left[2(T \ln T)^{2} \partial_{m}^{4} \mathcal{G}(m, T)\right. \\
&\left.+2 T(\ln T)^{2} \partial_{m}^{2} \mathcal{G}(m, T)\right]+\cdots, \tag{21}
\end{align*}
$$

where $\mathcal{G}(m, T)$ (without the subscript $H$ ) is the propagator for standard Brownian motion ( $H=\frac{1}{2}$ ) with unit diffusivity. In this section, we restrict our analysis to second order in $\varepsilon$, which is enough to verify formulas (8)-(10). An all-orders analysis is deferred to App. C.

Using Eqs. (7) and (14) in Eq. (20) we get

The second term comes from the order- $\varepsilon$ contribution to the diffusion constant (14) inserted into Eq. (7).

Each term in the expansion of $W_{H}$ can now be evaluated as an average with a Brownian measure of diffusivity $D$. The path integral measure $\mathcal{D}[x]$ is defined such that the leading term

is the normalized propagator $Z_{T}(0, m)$ for standard Brownian motion with diffusivity $D$, starting from $x=0$ at $t=0$, and ending in $x=m$ at $t=T$. (For $D=1, Z_{T}(0, m) \equiv \mathcal{G}(m, T)$ in Eq. (21).)

For the linear-order term in Eq. (22b) we use Eq. (10a) and the identity (M11) derived in App. M to obtain

In a similar calculation, the normalization in Eq. (20) is obtained from Eqs. (23), (26), and (29) as

To see that Eq. (31) agrees with Eq. (21) we use Eq. (14) in Eq. (23) and write

for large $\Lambda$, that Eq. (32) agrees with Eq. (21).
Remark: The asymptotics of the integral in Eq. (35) is numerically verified in Mathematica, with results shown in Fig. 3.

Remark: The analogue of the integral in Eq. (35) with ultraviolet cutoff $\omega$ in time is

As a consistency check we verified that for small $\omega$, and using the identification Eq. (13), the integral yields the asymptotics in Eq. (35).

Remark: In our derivation of Eq. (21) using Eq. (7) we interchanged the small- $\varepsilon$ and large- $\Lambda$ limits. Agreement of the final result in Eq. (21) shows that this step is justified. We assume the same property in our perturbation analysis in the observables of the three arcsine-laws.

Remark: The analysis would be simpler with the normalordered Action in Eq. (16), because then terms $f_{5}$ and $f_{6}$ in Eq. (29) vanish.

## IV. A GENERALIZATION OF THE THREE ARCSINE-LAWS

Unlike for standard Brownian motion, the probabilities for the three observables $t_{\text {last }}, t_{\text {max }}$, and $t_{\text {pos }}$ all differ. Selfaffinity of an fBm (invariance under rescaling of space with $T^{H}$ ) means that the three probabilities are a function of the rescaled variable $\vartheta=t / T$ ( $t$ being $\left.t_{\text {last }}, t_{\text {max }}, t_{\text {pos }}\right)$. They can be written as

p_{\text {last }}(\vartheta) & =\frac{\mathcal{N}_{\text {last }}}{\pi \vartheta^{H}(1-\vartheta)^{1-H}} \mathrm{e}^{\mathcal{F}^{\text {last }}(\vartheta, H)},  \tag{36}\\
p_{\max }(\vartheta) & =\frac{\mathcal{N}_{\max }}{\pi[\vartheta(1-\vartheta)]^{H}} \mathrm{e}^{\mathcal{F}^{\max }(\vartheta, H)},  \tag{37}\\
p_{\text {pos }}(\vartheta) & =\frac{\mathcal{N}_{\text {pos }}}{\pi[\vartheta(1-\vartheta)]^{H}} \mathrm{e}^{\mathcal{F}^{\text {pos }}(\vartheta, H)} . \tag{38}
\end{align*}
$$

The divergences in the prefactor of the exponential terms are predicted using a scaling argument (discussed in Sec. IV B) for $\vartheta \rightarrow 0$ and $\vartheta \rightarrow 1$. They are linked to earlier results about the persistence exponent $\Theta=1-H[32,33,59]$. The terms $\mathcal{F}$ in the exponential are non-trivial and remain finite over the full range of $\vartheta$. We use the convention that the integral of each $\mathcal{F}$ function over $\vartheta$ vanishes, which together with the normalization $\int_{0}^{1} d \vartheta p(\vartheta)=1$ fixes the constants $\mathcal{N}$.

For $H=\frac{1}{2}$, all three $\mathcal{F}$ functions vanish, $H=1-H$, and the expressions (36) to (38) reduce to the same well-known result of standard Brownian motion ("arcsine law"). For $H \neq$ $\frac{1}{2}$, they can be written as a perturbation expansion in $\varepsilon=H-$ $\frac{1}{2}$,

For the leading-order terms we find

with

This is the simplest form we found. Alternative expressions were given in $[60-62,64]$, using that $\arctan (x)+$ $\arctan \left(\frac{1}{x}\right)=\frac{\pi}{2}$. Yet another equivalent form is given in Eq. (6) of [67]. We note that the expression (40b) is symmetric under $\vartheta \rightarrow 1-\vartheta$. This can be understood from the symmetry of the problem. We do not have an intuitive understanding of the equality of $\mathcal{F}_{1}^{\text {pos }}$ and $\mathcal{F}_{1}^{\text {max }}$, while the vanishing of $\mathcal{F}_{1}^{\text {last }}$ in Eq. (40) can easily be understood from perturbation theory [64].

Expressions for the sub-leading terms $\mathcal{F}_{2}$ can be written as integrals, which are hard to evaluate analytically. For $t_{\text {last }}$, it is given up to an additive constant by

where $\Psi^{\text {last }}\left(y_{1}, y_{2}, z\right)$ is symmetric in $\left(y_{1}, y_{2}\right)$ and given by

&\left.+\Theta\left(z-y_{1}-y_{2}\right) \sqrt{z-y_{1}-y_{2}}\right), \tag{41b}
\end{align*}

with $\Theta(x)$ being the Heaviside step function. Expressions for $\mathcal{F}_{2}^{\max }$ and $\mathcal{F}_{2}^{\text {pos }}$ are cumbersome and given later.

In order that the reader can use our results, we give simple but rather precise approximations for the results obtained after

numerical integration.

These approximate functions are estimated respecting symmetries in the problem, i.e. that $\mathcal{F}_{2}^{\text {pos }}(\vartheta)$ and $\mathcal{F}_{2}^{\max }(\vartheta)$ are symmetric under the exchange of $\vartheta \rightarrow 1-\vartheta$ while $\mathcal{F}_{2}^{\text {last }}(\vartheta)$ is not.

Remark: We stated above that $p_{\text {pos }}(\vartheta)$ and $p_{\text {max }}(\vartheta)$ are symmetric around $\vartheta=\frac{1}{2}$, while $p_{\text {last }}(\vartheta)$ is not (except for $H=$ $\frac{1}{2}$ ). Symmetry of the first two probabilities is due to the observation that $x_{t}$ and $X_{T}-x_{T-t}$ have the same law. For $p_{\text {last }}$ the asymmetry is easy to see from the almost-straight-line trajectories for $H \simeq 1$ in Fig. 1, which makes $\vartheta=0$ the most probable value. This is reflected in the small- $\vartheta$ divergence of the distribution (36) in the limit of $H \rightarrow 1$.

## A. Comparison with numerical results

An efficient implementation of fBm on a computer is nontrivial due to its long-range correlations in time. For this paper, we use the Davis-Harte algorithm [70, 71], which generates sample trajectories drawn from a Gaussian probability with covariance (1) in a time of order $N \ln (N)$, given $N$
equally spaced discretization points. Details of this algorithm are given in App. D. Interestingly, for the first-passage time, recently an algorithm was introduced which grows as $\ln (N)^{3}$, albeit accepting a small error probability [66, 72, 73], allowing for even more precise estimates.

Results for the three probabilities from our computer simulations are shown in figure 4 for $H=0.33$. They are obtained by averaging over $5 \times 10^{9}$ sample trajectories, each generated with $2^{13}$ discrete-time steps. The two distributions $p_{\max }(\vartheta)$ and $p_{\text {pos }}(\vartheta)$ are almost indistinguishable, as predicted in their theoretical expressions in Eqs. (37) and (38).

Figure 4 also shows that $p_{\text {last }}(\vartheta)$ behaves markedly differently from the other two distributions; especially, it is asymmetric under the exchange $\vartheta \rightarrow 1-\vartheta$. This asymmetry in exponents is reversed around $H=\frac{1}{2}$, as shown in the inset of figure 4. This can be seen in the scaling form in Eq. (36).

A comparison of numerical data for $H=0.33$ with their corresponding theoretical result in Eqs. (36)-(38) are shown in Fig. 5. They are in excellent agreement. Deviations are visible for higher values of $H$ as shown in Fig. 6 for a set of increasing values of $H \geq \frac{1}{2}$. We see a perfect agreement between theoretical and numerical results for $H=\frac{1}{2}$, (i.e. $\varepsilon=0$ ). The agreement is very good for small $\varepsilon=H-\frac{1}{2}$, but deviations can be seen as $\varepsilon$ is increased beyond $|\varepsilon| \approx 0.25$, i.e. $H \leq 0.25$ or $H \geq 0.75$.

The difference between $p_{\text {last }}$ and $p_{\text {max }}$ first appears in the second-order term $\mathcal{F}_{2}$ in Eq. (39). In Fig. 7 we plot our theoretical results of $\mathcal{F}_{2}(\vartheta)$ alongside the results from computer simulations. This give a finer verification of our theory. To illustrate this procedure, we use Eq. (38) to define

\end{equation*}

Then, $\mathcal{F}_{2, \varepsilon}^{\text {pos }}(\vartheta)=\mathcal{F}_{2}^{\text {pos }}(\vartheta)+\mathcal{O}(\varepsilon)$ and it contains all terms in the exponential in Eq. (38) except $\mathcal{F}_{1}^{\text {pos }}(\vartheta)$. We can further improve this estimate by observing that the sub-leading term in $\mathcal{F}_{2, \varepsilon}^{\mathrm{pos}}(\vartheta)$ is odd in $\varepsilon$. Define

\overline{\mathcal{F}}_{2, \varepsilon}^{\mathrm{pos}}(\vartheta):=\frac{1}{2}\left[\mathcal{F}_{2, \varepsilon}^{\mathrm{pos}}(\vartheta)+\mathcal{F}_{2,-\varepsilon}^{\mathrm{pos}}(\vartheta)\right] \tag{46}
\end{equation*}
$$

then $\overline{\mathcal{F}}_{2, \varepsilon}^{\mathrm{pos}}(\vartheta)$ differs from the theoretical $\mathcal{F}_{2}^{\text {pos }}(\vartheta)$ by order $\varepsilon^{2}$ or higher, for small $\varepsilon$, equivalent to an order $\varepsilon^{4}$ correction to $p_{\text {last }}(\vartheta)$.

A comparison of $\overline{\mathcal{F}}_{2, \varepsilon}^{\mathrm{pos}}(\vartheta)$ extracted from numerical simulations of $p_{\text {pos }}(\vartheta)$ to the theoretical result of $\mathcal{F}_{2}^{\mathrm{pos}}(\vartheta)$ is shown in Fig. 7 for $\varepsilon= \pm \frac{1}{6}$ (i.e. for $H=\frac{2}{3}$ and $\frac{1}{3}$ ). The figure also contains a similar comparison for $\mathcal{F}_{2}^{\text {last }}(\vartheta)$ and $\mathcal{F}_{2}^{\max }(\vartheta)$, with their corresponding numerical results. One sees the excellent agreement between results from our theory and numerical simulations. We remind that these are sub-sub-leading corrections, almost indiscernible in the probability density $p(\vartheta)$ shown on Fig. 5.

An important observation from Fig. 7 is that for all three observables $\mathcal{F}_{2}(\vartheta)$ is finite in the entire range of $\vartheta$. We note that the amplitude of $\mathcal{F}_{2}^{\text {last }}(\vartheta)$ is about ten times larger than $\mathcal{F}_{2}^{\text {pos }}(\vartheta)$ and $\mathcal{F}_{2}^{\max }(\vartheta)$. The former also shows the largest

deviations from our theoretical result, especially for $\vartheta \rightarrow 0$. These indicate the presence of sub-leading terms of order $\varepsilon^{4}$, or higher in $p$.

The difference between $p_{\text {pos }}(\vartheta)$ and $p_{\max }(\vartheta)$ first appears at second order in perturbation theory. To underline that $\mathcal{F}_{2}^{\mathrm{pos}}(\vartheta)$ and $\mathcal{F}_{2}^{\max }(\vartheta)$ in Eqs. (43) and (44) are distinct functions, we show in Fig. 8 their difference

$$
\begin{align*}
\delta \mathcal{F}_{2}(\vartheta) & =\mathcal{F}_{2}^{\max }(\vartheta)-\mathcal{F}_{2}^{\mathrm{pos}}(\vartheta) \\
& =\lim _{\varepsilon \rightarrow 0} \frac{1}{\varepsilon^{2}} \ln \left(\frac{p_{\max }(\vartheta)}{p_{\mathrm{pos}}(\vartheta)}\right) . \tag{47}
\end{align*}
$$

The theoretical result of the difference shows excellent agreement with the numerical data for $\overline{\mathcal{F}}_{2, \varepsilon}^{\max }(\vartheta)-\overline{\mathcal{F}}_{2, \varepsilon}^{\mathrm{pos}}(\vartheta)$ defined following the same conventions as in Eq. (46). This proves that the laws for $t_{\text {max }}$ and $t_{\text {pos }}$ are indeed different.

## B. Scaling analysis

The prefactor of the exponential in formula Eqs. (36)-(38) can be predicted using scaling arguments. The simplest one is $p_{\text {last }}(\vartheta)$, which is the probability that the fBm is at the origin at time $\vartheta$ and does not return for the remaining time $1-\vartheta$.
(We put the total time $T=1$, s.t. $\vartheta=t$.) The probability for the first part of the event scales as $\vartheta^{-H}$, see Eq. (18). The second part scales as $\vartheta^{-\theta}$, where $\theta=1-H$ is the persistent exponent $[32,33,59]$. Combining the two gives the prefactor in Eq. (36).

The scaling argument for $p_{\max }(\vartheta)$ is more involved, and was first discussed in Refs. [59, 62, 64]. One starts with the relation

\begin{equation*}
\mathcal{P}_{T}(m)=\frac{d \mathscr{S}_{T}(m)}{d m} \tag{48}
\end{equation*}
$$

where $\mathcal{P}_{T}(m)$ is the probability for the position of the maximum $m$ for an fBm in a time interval $T$ started at the origin; $\mathscr{S}_{T}(m)$ is the survival probability up to time $T$ for an fBm started at $m>0$, in presence of an absorbing wall at the origin. Self-affinity of an fBm suggests the scaling form

$$
\begin{equation*}
\mathcal{P}_{T}(m)=\frac{1}{T^{H}} g_{1}\left(\frac{m}{T^{H}}\right) ; \quad \mathscr{S}_{T}(m)=g_{2}\left(\frac{m}{T^{H}}\right) \tag{49}
\end{equation*}
$$

which leads to

$$
\begin{equation*}
g_{1}(x)=g_{2}^{\prime}(x) \tag{50}
\end{equation*}
$$

To be consistent with the result for the persistence exponent [32, 33], one must have $g_{2}(x) \sim x^{\frac{\theta}{H}}$ for small $x$. This leads

to $g_{1}(x) \sim x^{\frac{\theta}{H}-1}$, equivalent to

$$
\begin{equation*}
\mathcal{P}_{T}(m) \sim \frac{m^{\frac{\theta}{H}-1}}{T^{\theta}} \quad \text { for small } m \tag{51}
\end{equation*}
$$

To relate to the distribution $P_{T}\left(t_{\max }\right)$ of $t_{\max }$ we use that at small $t_{\max }$ the maximum $m$ is also small and $m \sim t_{\max }^{H}$. This leads to

$$
\begin{equation*}
P_{T}\left(t_{\max }\right)=\mathcal{P}_{T}(m) \frac{d m}{d t_{\max }} \sim \frac{1}{t_{\max }}\left(\frac{t_{\mathrm{max}}}{T}\right)^{\theta} \tag{52}
\end{equation*}
$$

Substituting $\theta=1-H$ one gets

$$
\begin{equation*}
P_{T}\left(t_{\max }\right) \sim \frac{1}{T}\left(\frac{t_{\max }}{T}\right)^{-H} \tag{53}
\end{equation*}
$$

and equivalently

$$
\begin{equation*}
p_{\max }(\vartheta)=T P_{T}(\vartheta T) \sim \vartheta^{-H} \quad \text { for small } \vartheta \tag{54}
\end{equation*}
$$

Using the symmetry of the probability $p_{\max }(\vartheta)$ under $\vartheta \rightarrow$ $1-\vartheta$ one gets $(1-\vartheta)^{-H}$ for $\vartheta \rightarrow 1$. This gives the prefactor in Eq. (37).

A similar argument relating to the persistent exponent [74] can be constructed for the distribution of $t_{\text {pos }}$. For $t_{\text {pos }} \ll$ $T$, probability $P_{T}\left(t_{\mathrm{pos}}\right)$ for an fBm to remain positive of net $t_{\text {pos }}$ time, relates to persistence probability for the fBm to stay negative for most of its total duration $T$. This means, for $1 \ll$ $t_{\text {pos }} \ll T$,

$$
\begin{equation*}
P_{T}\left(t_{\mathrm{pos}}\right) \sim T^{-\theta} \tag{55}
\end{equation*}
$$

with the persistent exponent $\theta$. For this $T$-dependence to be consistent with the re-scaled probability $P_{T}(\vartheta T)=$ $\frac{1}{T} p_{\text {pos }}(\vartheta)$, one must have

$$
\begin{equation*}
p_{\text {pos }}(\vartheta) \sim \vartheta^{\theta-1} \quad \text { for } \vartheta \rightarrow 0 \tag{56}
\end{equation*}
$$

giving the small $\vartheta$ divergence in Eq. (38). The symmetry un$\operatorname{der} \vartheta \rightarrow 1-\vartheta$ gives the divergence near $\vartheta \rightarrow 1$.

## C. Comparison to an exact result

In Ref. [12] the first few moments of $t_{\text {pos }}$ were calculated analytically for an fBm of $H=\frac{1}{4}$. It is straightforward to generalize this analysis for arbitrary $H$. For the fraction of positive time $\vartheta=t_{\text {pos }} / T$, we obtain the first three moments: $\langle\vartheta\rangle=\frac{1}{2}$ (obvious from the symmetry of the distribution),

$$
\begin{align*}
& \left\langle\vartheta^{2}\right\rangle=\frac{1}{4}+\frac{1}{2 \pi} \int_{0}^{1} d r \arcsin R(r)  \tag{57a}\\
& \left\langle\vartheta^{3}\right\rangle=\frac{1}{8}+\frac{3}{4 \pi} \int_{0}^{1} d r \arcsin R(r) \tag{57b}
\end{align*}
$$

where

$$
\begin{equation*}
R(r)=\frac{1}{2 r^{H}}\left[1+r^{2 H}-(1-r)^{2 H}\right] \tag{57c}
\end{equation*}
$$

It is hard to determine higher moments. The problem maps to the orthant probability problem for a multivariate Gaussian, which is still unsolved [75].

A perturbation expansion of Eq. (57) in $\varepsilon=H-\frac{1}{2}$ gives

$$
\begin{align*}
& \left\langle\vartheta^{2}\right\rangle=\frac{3}{8}+\frac{\varepsilon}{4}(\ln 4-1)+\frac{\varepsilon^{2}}{24}\left(6 \ln ^{2} 4-\pi^{2}\right)+\cdots  \tag{58a}\\
& \left\langle\vartheta^{3}\right\rangle=\frac{5}{16}+\frac{3 \varepsilon}{8}(\ln 4-1)+\frac{\varepsilon^{2}}{16}\left(6 \ln ^{2} 4-\pi^{2}\right)+\cdots \tag{58b}
\end{align*}
$$

Terms up to linear order are reproduced using our perturbation result Eq. (38). The $\varepsilon^{2}$ order terms ( 0.0693 for $\left\langle\vartheta^{2}\right\rangle$ and 0.1040 for $\left\langle\vartheta^{3}\right\rangle$ ) obtained using the numerical approximation Eq. (44) agree with the exact result in Eq. (58) up to the third decimal place. (This is a $0.2 \%$ disagreement, as apposed to a $40 \%$ disagreement if $\mathcal{F}_{2}^{\text {pos }}$ is ignored in Eq. (39c).)

A comparison of the exact result for the moments with their results obtained using Eq. (38) is shown in Fig. 9.

## V. OVERVIEW OF THEORETICAL ANALYSIS

Before we present details of the derivation for Eqs. (36)(38), we give an overview of our approach. Our calculation is done using a double Laplace transformation $\mathcal{D}$ for the probability $P_{T}(\tau)$, defined by

$$
\begin{align*}
\widetilde{P}(\lambda, s) & =\mathscr{D}_{\substack{T \rightarrow \lambda \\
T \rightarrow s}} \odot P_{T}(\tau), \quad \text { with }  \tag{59}\\
\mathscr{D}_{\substack{\tau \rightarrow \lambda \\
T \rightarrow s}} \odot P_{T}(\tau) & :=\int_{0}^{\infty} d T \int_{0}^{T} d \tau e^{-s T-\lambda \tau} P_{T}(\tau) . \tag{60}
\end{align*}
$$

For the re-scaled probability $p(\vartheta):=T P_{T}(\vartheta T)$ and it's Laplace transform

$$
\begin{equation*}
\widetilde{p}(\kappa)=\int_{0}^{\infty} d \vartheta e^{-\kappa \vartheta} p(\vartheta) \tag{61}
\end{equation*}
$$

the $\mathscr{D}$-transformation gives

$$
\begin{equation*}
\widetilde{P}(\lambda, s)=\frac{1}{s} \widetilde{p}\left(\frac{\lambda}{s}\right), \text { with } \widetilde{p}(\kappa)=\int_{0}^{1} d \vartheta \frac{p(\vartheta)}{1+\kappa \vartheta} \tag{62}
\end{equation*}
$$

Complex analysis using the residue theorem gives the corresponding inverse transformation (see App. E for a derivation),

$$
\begin{equation*}
p(\vartheta)=\frac{1}{2 \pi i} \lim _{\delta \rightarrow 0^{+}} \frac{\widetilde{p}\left(-\frac{1}{\vartheta}-i \delta\right)-\widetilde{p}\left(-\frac{1}{\vartheta}+i \delta\right)}{\vartheta} \tag{63}
\end{equation*}
$$

Equivalently, one can write

$$
\begin{equation*}
p(\vartheta)=\frac{1}{2 \pi i} \lim _{\phi \rightarrow \pi^{-}}\left[\kappa \widetilde{p}(\kappa)-\kappa^{\star} \widetilde{p}\left(\kappa^{\star}\right)\right]_{\kappa=\frac{e^{i \phi}}{\vartheta}} \tag{64}
\end{equation*}
$$

where the limit is taken from $\phi$ below $\pi$, and the star $(\star)$ denotes complex conjugation.

The analysis can be simplified by considering the form of results in Eqs. (36)-(38) expected from scaling arguments. We write

$$
\begin{equation*}
p(\vartheta)=\frac{e^{\mathcal{F}(\vartheta, H)-\left(H-\frac{1}{2}\right) \mathcal{R}(\vartheta)}}{\pi \sqrt{\vartheta(1-\vartheta)}} \tag{65}
\end{equation*}
$$

with $\mathcal{R}(\vartheta)=\ln \frac{\vartheta}{(1-\vartheta)}$ for $t_{\text {last }}$ and $\mathcal{R}(\vartheta)=\ln \vartheta(1-\vartheta)$ for $t_{\max }$ and $t_{\text {pos }}$. (In writing Eq. (65) the normalization constant $\mathcal{N}$ from Eqs. (36)-(38) is absorbed in $\mathcal{F}$.) Then, from Eqs. (64) and (65) we write

$$
\begin{equation*}
\widetilde{p}(\kappa)=\frac{e^{\widetilde{\mathcal{F}}(\kappa, H)}}{\sqrt{1+\kappa}} \tag{66}
\end{equation*}
$$

such that

$$
\begin{equation*}
e^{\mathcal{F}(\vartheta, H)-\left(H-\frac{1}{2}\right) \mathcal{R}(\vartheta)}=\mathcal{K}_{\kappa \rightarrow \vartheta}^{-1} \odot e^{\widetilde{\mathcal{F}}(\kappa, H)} \tag{67}
\end{equation*}
$$

Here we define the transformation

$$
\begin{equation*}
\mathcal{K}_{\kappa \rightarrow \vartheta}^{-1} \odot f(\kappa) \equiv \lim _{\phi \rightarrow \pi-} \mathscr{R}\left[f\left(\frac{e^{i \phi}}{\vartheta}\right)\right] \tag{68}
\end{equation*}
$$

with $\mathscr{R}$ denoting the real part.
In our derivation of the probabilities in Eqs. (36)-(38), we first calculate $\widetilde{\mathcal{F}}(\kappa, H)$, and then use Eq. (67) to obtain $\mathcal{F}(\vartheta, H)$. To do this order by order in a perturbation expansion in $\varepsilon=H-\frac{1}{2}$, write

$$
\begin{equation*}
\widetilde{\mathcal{F}}(\kappa, H)=\varepsilon \widetilde{\mathcal{F}}_{1}(\kappa)+\varepsilon^{2} \widetilde{\mathcal{F}}_{2}(\kappa)+\mathcal{O}\left(\varepsilon^{3}\right) \tag{69a}
\end{equation*}
$$

Using this expansion in Eq. (67) we get Eq. (39) with

$$
\begin{align*}
\mathcal{F}_{1}(\vartheta)= & \mathcal{R}(\vartheta)+\mathcal{K}_{\kappa \rightarrow \vartheta}^{-1} \odot \widetilde{\mathcal{F}}_{1}(\kappa),  \tag{69b}\\
\mathcal{F}_{2}(\vartheta)= & -\frac{1}{2}\left[\mathcal{F}_{1}(\vartheta)-\mathcal{R}(\vartheta)\right]^{2} \\
& +\mathcal{K}_{\kappa \rightarrow \vartheta}^{-1} \odot\left[\widetilde{\mathcal{F}}_{2}(\kappa)+\frac{1}{2} \widetilde{\mathcal{F}}_{1}(\kappa)^{2}\right] . \tag{69c}
\end{align*}
$$

Remark: For completeness and for verification purposes, let us write the inverse transformation of Eq. (68),

$$
\begin{equation*}
\mathcal{K}_{\vartheta \rightarrow k} \odot f(\vartheta):=\frac{1}{\pi} \int_{0}^{1} d \vartheta \frac{\sqrt{1+\kappa}}{1+\kappa \vartheta} \frac{f(\vartheta)}{\sqrt{\vartheta(1-\vartheta)}} \tag{70}
\end{equation*}
$$

A list of the used inverse $\mathcal{K}$-transforms is given in App. F.
Remark: From the normalization condition $\int_{0}^{1} d \vartheta p(\vartheta)=1$ one can see in Eq. (62) that $\widetilde{p}(0)=1$ and therefore in Eq. (66),

$$
\begin{equation*}
\tilde{\mathcal{F}}(\kappa, H)=0 \quad \text { for } \kappa=0 \tag{71}
\end{equation*}
$$

Remark: There are two reasons for performing our analysis using Laplace transform. The first is that convolutions in time are factorized, the second that integrations over space can be done over the Laplace-transformed propagator, but not the propagator in time. This will become clear in the analysis in the following sections.

## VI. DISTRIBUTION OF TIME $t_{\text {last }}$ FOR THE LAST VISIT TO THE ORIGIN

The analysis for the distribution of $t_{\text {last }}$ is the simplest among the three observables, and we present it first. The probability of $t_{\text {last }}=\tau$ for an fBm in a time window $[0, T]$ can be determined by

$$
\begin{equation*}
P_{T}\left(t_{\text {last }}=\tau\right)=\frac{W(\tau, T)}{N(T)} \quad \text { for } x_{0} \rightarrow 0 \tag{72}
\end{equation*}
$$

where $W(\tau, T)$ is twice the weight of fBm trajectories that start at $X_{0}=0$, pass through $X_{\tau}=x_{0}>0$, and remain positive for the rest of the time (see Fig. 10 for an illustration). Note that the factor of 2 accounts for the possibility that the final position is either $m>0$, or $m<0$. Here $N(T)$ is the normalization

$$
\begin{equation*}
N(T)=\int_{0}^{T} d \tau W(\tau, T) \tag{73}
\end{equation*}
$$

(To keep notations simple, we avoid explicit reference to $x_{0}$, unless necessary.)

Formally, we write

$$
\begin{gather*}
W(\tau, T)=2 \int_{0}^{\infty} d m \int_{x(0)=0}^{x(T)=m} \mathcal{D}[x] \delta\left(x(\tau)-x_{0}\right) \\
\quad \times \prod_{t=\tau}^{T} \Theta(x(t)) e^{-S} \tag{74}
\end{gather*}
$$

The perturbative expansion in Eq. (7) of the action leads to a similar expansion for $W$, given by

$$
\begin{equation*}
W(\tau, T)=W_{0}(\tau, T)+\varepsilon W_{1}(\tau, T)+\varepsilon^{2} W_{2}(\tau, T)+\ldots \tag{75}
\end{equation*}
$$

with

$$
\begin{align*}
& W_{0}(\tau, T)=2 \int_{0}^{\infty} d m\langle 1\rangle_{m}  \tag{76}\\
& W_{1}(\tau, T)=\int_{0}^{\infty} d m\left\langle\left\langle\frac{S_{1}}{D}\right\rangle\right\rangle_{m}  \tag{77}\\
& W_{2}(\tau, T)=\int_{0}^{\infty} d m\left\langle\left\langle\frac{S_{1}^{2}}{4 D^{2}}-2 \frac{S_{2}}{D}\right\rangle\right\rangle_{m} . \tag{78}
\end{align*}
$$

The double-angular brackets denote (for $m>0$ ) the average over trajectories as sketched in Fig. 10 with a standard Brownian measure,

$$
\begin{equation*}
\langle O[x]\rangle_{m}:=\int_{x(0)=0}^{x(T)=m} \mathcal{D}[x] \delta\left(x(\tau)-x_{0}\right) \prod_{t=\tau}^{T} \Theta(x(t)) e^{-\frac{S_{0}}{D}} O(x(t)) . \tag{79}
\end{equation*}
$$

This definition of double-angular brackets is specific to the trajectories used here, its definition in other sections will include the corresponding boundary conditions needed there.

## A. Zeroth order term

In terms of the free Brownian propagator Eq. (23) and the propagator in presence of an absorbing wall,

$$
\begin{equation*}
Z_{t}^{+}\left(x_{1}, x_{2}\right)=\int_{x(0)=x_{1}}^{x(t)=x_{2}} \mathcal{D}[x] \prod_{r=0}^{t} \Theta(x(r)) e^{-\frac{S_{0}}{D}} \tag{80}
\end{equation*}
$$

we write Eq. (76) as

$$
\begin{equation*}
W_{0}(\tau, T)=2 \int_{0}^{\infty} d m Z_{\tau}\left(0, x_{0}\right) Z_{T-\tau}^{+}\left(x_{0}, m\right) \tag{81}
\end{equation*}
$$

Its double Laplace transformation Eq. (60) denoted by

$$
\begin{equation*}
\widetilde{W}_{0}(\lambda, s)=\mathscr{D}_{\substack{\tau \rightarrow \lambda \\ T \rightarrow s}} \odot W_{0}(\tau, T) \tag{82}
\end{equation*}
$$

is

$$
\begin{equation*}
\widetilde{W}_{0}(\lambda, s)=2 \int_{0}^{\infty} d m \widetilde{Z}_{s+\lambda}\left(0, x_{0}\right) \widetilde{Z}_{s}^{+}\left(x_{0}, m\right) \tag{83}
\end{equation*}
$$

Here $\widetilde{Z}_{s}$ and $\widetilde{Z}_{s}^{+}$are the Laplace transforms of $Z_{t}$ and $Z_{t}^{+}$, given by

$$
\begin{align*}
\widetilde{Z}_{s}\left(x_{1}, x_{2}\right) & =\int_{0}^{\infty} d t e^{-s t} Z_{t}\left(x_{1}, x_{2}\right) \\
& =\frac{e^{-\sqrt{\frac{s}{D}}\left|x_{1}-x_{2}\right|}}{2 \sqrt{s D}} \tag{84a}
\end{align*}

and

\widetilde{Z}_{s}^{+}\left(x_{1}, x_{2}\right) & =\int_{0}^{\infty} d t e^{-s t} Z_{t}^{+}\left(x_{1}, x_{2}\right) \\
& =\frac{e^{-\sqrt{\frac{s}{D}}\left|x_{1}-x_{2}\right|}-e^{-\sqrt{\frac{s}{D}}\left|x_{1}+x_{2}\right|}}{2 \sqrt{s D}} \tag{84b}
\end{align*}
$$

Using these results in Eq. (83) and evaluating the integral for small $x_{0}$ we get, (see Eq. (L5))

Remark: The factorization in Eq. (83) results from the identity

where $\widetilde{g}(s)$ and $\widetilde{f}(s)$ are the Laplace transforms of $g(t)$ and $f(t)$, respectively.

Remark: From Eq. (85) it is straightforward to verify the arcsine-law (4) for Brownian motion. One can use $D=$ 1 for $\varepsilon=0$ in Eq. (85), and verify that $W_{0}(\vartheta T, T) \simeq$ $x_{0}[\pi T \sqrt{\vartheta(1-\vartheta)}]^{-1}$. Then, Eqs. (72) and (73) lead to the distribution (4).

## B. Linear order: 1-loop diagrams

Using $S_{1}$ from Eq. (10a) we explicitly write Eq. (77) as

For convenience we use a graphical representation of the expression in Eq. (87). We write the amplitude in three parts, according to the relative order of times $r_{1}, r_{2}$, and $\tau$, as illustrated in the 1-loop diagrams in Fig. 11.

Remark: Diagrams in Fig. 11 consists of couplings between a single pair of points, resulting in the $y$-integral in Eq. (87). In analogy with field theory, we refer to them as 1-loop diagrams, with $y$ representing the loop-variable to be integrated over. In Sec. VIC, i.e. at second order, amplitudes involve couplings between two pairs, resulting into two $y$ integrations, and therefore referred to as 2-loop diagrams.

Following our convention for the diagrams in Fig. 11 we write Eq. (87) as

& A_{3}(\tau, T) \\
& =\frac{1}{D} \int_{0}^{\infty} d m \int_{0}^{\Lambda} d y J_{\tau}\left(0, x_{0} ;-y\right) e^{-y \tau} J_{T-\tau}^{+}\left(x_{0}, m ; y\right) \tag{88d}
\end{align*}

We defined

and its analogue $J^{(+)}$in presence of an absorbing wall at $x=$ 0. The integral over time in Eq. (89) is interpreted as in Eq. (15), i.e. with an ultraviolet cutoff $\Lambda$ on $y$.

Using Eq. (86) we write the double Laplace transform Eq. (60) of the diagrams $A_{i}$ in terms of Laplace transforms of $Z$ and $Z^{+}$in Eq. (84), as well as Laplace transforms for $J$ and $J^{+}$. Expressions are obtained in App. N, and summarized here,

\end{aligned}

Using Eqs. (84), (N8), and (N13) gives, for small $x_{0}$,

& \widetilde{A}_{2}(s \kappa, s) \simeq \frac{x_{0}}{D s} \times \frac{\widetilde{\mathcal{A}}(1)}{\sqrt{1+\kappa}}
\end{aligned}
$$

with

\begin{equation*}
\widetilde{\mathcal{A}}(z)=\int_{0}^{\Lambda / s} \frac{d y}{y^{2}}(\sqrt{z+y}-\sqrt{z})^{2} \tag{90}
\end{equation*}
$$

A similar analysis for $A_{3}$ in Eq. (88d), using Eqs. (N1) and (N5), shows that the corresponding double Laplace transform $\widetilde{A}_{3} \sim x_{0}^{2}$, for small $x_{0}$. As a result, the double Laplace transform of $W_{1}(\tau, T)$ defined in analogy to Eq. (82) reads, for small $x_{0}$,

Remark: The reason for $\widetilde{A}_{3}$ to vanish as $x_{0}^{2}$ or faster, for small $x_{0}$, can be understood from a simple observation. In the limit of $x_{0} \rightarrow 0, J_{t}\left(0, x_{0} ; y_{1}, \ldots, y_{n}\right)$ in Eq. (89) vanishes for odd $n$. One way to see this is by noting that, in the limit of $x_{0} \rightarrow 0$, for each trajectory with a certain $\dot{x}(r)$, there is a mirror trajectory $-\dot{x}(r)$, with equal probability. In comparison, $J^{+}\left(x_{0}, m ; y_{1}, \ldots, y_{n}\right)$ vanishes for $x_{0} \rightarrow 0$ because of the absorbing boundary. This means that in Eq. (88d), both $J$ and $J^{+}$are at least of order $x_{0}$, and therefore $\widetilde{A}_{3} \sim x_{0}^{2}$, to the least. We shall see later that for a similar reason the amplitudes of the 2-loop diagrams $B$ and $C$ in Fig. 14 are of order $x_{0}^{2}$, for small $x_{0}$.

Remark: We shall see that these diagrams $A_{1}, A_{2}$, and $A_{3}$ contribute to the propagator $W_{1}$ in Eq. (88a), thus to the scaling prefactor in Eq. (36), but they do not feed into the exponential term $\mathcal{F}^{\text {last }}$.

## C. Quadratic order: 2-loop diagrams

Using Eq. (10) we explicitly write the terms in Eq. (78) as

\end{aligned}

A graphical illustration of the amplitudes in Eq. (92) and Eq. (93) is shown in Figs. 12 and 13. Similar to the conventions in Fig. 11, a dashed line indicates an interaction between points $r_{i}$ and $r_{j}$ with an amplitude $e^{y\left(r_{i}-r_{j}\right)}$. The solid disks indicate the field derivative $\dot{x}\left(r_{i}\right)$ at point $r_{i}$. For a contracted point, indicated by a cross, the associated amplitude is $2 D$. A reason for this will be clear shortly. Empty points in Fig. 13 have an amplitude 1 .

We shall see that among these diagrams, only diagrams (a) and (c) contribute at the second order. This can be directly seen using the normal-ordered weight in Eq. (16). Here, we explicitly show why this happens.

We find that the amplitudes of diagrams (b) and ( $\mathrm{b}^{\prime}$ ) are equal, as are those of (d) and ( $\mathrm{d}^{\prime}$ ). To see this we use that
under Wick contraction between $\dot{x}\left(r_{1}\right)$ and $\dot{x}\left(r_{3}\right)$

\end{equation*}
$$

(A similar result holds for contraction of any pair of times.) One can see this as a consequence of $\delta\left(r_{i}-r_{j}\right)$ term in Eq. (M8), and its analogue in presence of an absorbing boundary. Using the result (94) in Eq. (92) for diagram (b) we write its amplitude as

& \quad \times e^{y_{1}\left(r_{1}-r_{2}\right)} e^{y_{2}\left(r_{1}-r_{4}\right)}\left\langle\left\langle\dot{x}\left(r_{2}\right) \dot{x}\left(r_{4}\right)\right\rangle\right\rangle_{m} \\
& =\frac{1}{D} \int_{0}^{\infty} d m \int_{0}^{\Lambda} d y_{1} d y_{2} \int_{0}^{T} d r_{2} \int_{r_{2}}^{T} d r_{4} \int_{0}^{r_{2}} d r_{1} \\
& \quad \times e^{y_{1}\left(r_{1}-r_{2}\right)} e^{y_{2}\left(r_{1}-r_{4}\right)}\left\langle\left\langle\dot{x}\left(r_{2}\right) \dot{x}\left(r_{4}\right)\right\rangle\right\rangle_{m}
\end{aligned}
$$

Following a relabeling of the dummy variables $r$ we see that the integral is equal to the amplitude of diagram ( $b^{\prime}$ ) from Eq. (93) and Fig. 13. A similar analysis shows equal amplitude for diagrams (d) and ( $\mathrm{d}^{\prime}$ ).

The amplitude of diagram (e), where all four times are contracted, is proportional to $W_{0}$ in Eq. (76), which can be seen by using

when all four points are contracted. This means that the contribution of (e) can be included in the normalization Eq. (36), and therefore ignored.

Considering the contribution of the diagrams in Figs. 12 and 13, resulting into Eq. (78), we see that the relevant contribution for $W_{2}$ comes from the 2-loop diagrams (a) and (c) in Fig. 12. Considering the relative position of the loops with respect to $\tau$, we write the amplitude $W_{2}$ as a sum of the following ten diagrams,

This is shown in Fig. 14. Explicit formulas of their amplitudes are given in App. G. We shall see that among these diagrams, only diagram $D$ contributes to the non-trivial term $\mathcal{F}^{\text {last }}$ in Eq. (36), whereas the remaining diagrams contribute to the power-law prefactor only.

Here, we present the double Laplace transformation Eq. (60) of the amplitude of these diagrams, for small $x_{0}$ limit. Their derivation is similar to those of the amplitude of zeroth and linear order terms in Eqs. $(85,91)$. We defer their explicit calculation to the App. G.

For small $x_{0}$, we get

The amplitude of the diagrams $B$ and $C$ is of order $x_{0}^{2}$ for small $x_{0}$,

\end{equation*}

This can be seen from the argument given in the remark below Eq. (91). Their explicit derivation is in Appendix G 2 d .

The amplitude for the remaining diagrams is of order $x_{0}$, and given as follows. For small $x_{0}$,

& \quad+\sqrt{z}\left(\sqrt{z}-\sqrt{z+y_{1}}-\sqrt{z+y_{2}}\right)\left[\sqrt{z+y_{1}}\right. \\
& \quad \times\left(\sqrt{z}-\sqrt{z+y_{1}}\right)+\sqrt{z+y_{2}}\left(\sqrt{z}-\sqrt{z+y_{2}}\right) \\
& \quad+\left(\sqrt{z}-\sqrt{z+y_{1}}-\sqrt{z+y_{2}}\right)^{2}- \\
& \left.\left.2\left(\sqrt{z+y_{1}+y_{2}}-\sqrt{z+y_{1}}-\sqrt{z+y_{2}}+\sqrt{z}\right)^{2}\right]\right\} . \tag{101}

Considering the amplitude of these 2-loop diagrams in Eq. (96) we get the double Laplace transform Eq. (60) of $W_{2}(\tau, T)$ in Eq. (78). For small $x_{0}$ it reads

## D. Result for $\mathcal{F}^{\text {last }}(\kappa, H)$

From the results in Eqs. (85), (91), and (105) we obtain the double Laplace transform Eq. (60) of $W(\tau, T)$ in Eq. (75) in an exponential form,

Here $x_{0}$ is small, and we used $D$ in Eq. (14) to explicitly write the exponential term $\widetilde{\mathcal{W}}=\varepsilon \widetilde{\mathcal{W}}_{1}+\varepsilon^{2} \widetilde{\mathcal{W}}_{2}+\cdots$, with

& -\widetilde{\mathcal{A}}(1+\kappa) \widetilde{\mathcal{A}}(1)+\widetilde{\mathcal{G}}(1+\kappa)+\widetilde{\mathcal{G}}(1) \\
& -\frac{1}{2}[\widetilde{\mathcal{A}}(1)-\widetilde{\mathcal{A}}(1+\kappa)]^{2}+2\left[1-\frac{\pi^{2}}{6}\right] . \tag{107b}

To relate to the exponential form in Eq. (66) we note that the Laplace transform of $N_{T}$ in Eq. (73) is

This means, for small $x_{0}, N(T) \equiv N$ is independent of $T$, and the double Laplace transform of $P_{T}(\tau)$ in Eq. (72) is

\widetilde{P}(\lambda, s) \simeq \frac{\widetilde{W}(\lambda, s)}{N} \quad \text { for small } x_{0} \tag{110}
\end{equation*}
$$

Then, using Eq. (106) and comparing with Eqs. (62) and (66) gives

\widetilde{\mathcal{F}}^{\text {last }}(\kappa, H)=\widetilde{\mathcal{W}}(\kappa)-\widetilde{\mathcal{W}}(0) \tag{111}
\end{equation*}
$$

which we shall need to determine $\mathcal{F}(\vartheta, H)$ in Eq. (67). The leading terms in its perturbation expansion Eq. (69a) is given by

\widetilde{\mathcal{F}}_{1}^{\text {last }}(\kappa)= & \widetilde{\mathcal{A}}(1)-\widetilde{\mathcal{A}}(1+\kappa),  \tag{112a}\\
\widetilde{\mathcal{F}}_{2}^{\text {last }}(\kappa)= & {[\widetilde{\mathcal{D}}(1+\kappa)-\widetilde{\mathcal{D}}(1)]+[\widetilde{\mathcal{E}}(1+\kappa)+\widetilde{\mathcal{G}}(1+\kappa)} \\
& \left.-\frac{1}{2} \widetilde{\mathcal{A}}^{2}(1+\kappa)-\left(\widetilde{\mathcal{E}}(1)+\widetilde{\mathcal{G}}(1)-\frac{1}{2} \widetilde{\mathcal{A}}^{2}(1)\right)\right] \tag{112b}
\end{align*}
$$

We have numerically verified that, for $\Lambda \rightarrow \infty$,

$$
\begin{equation*}
\widetilde{\mathcal{E}}(z)+\widetilde{\mathcal{G}}(z)-\frac{1}{2} \widetilde{\mathcal{A}}^{2}(z)=(1+\ln (2))^{2}-\frac{5 \pi^{2}}{12} \tag{113}
\end{equation*}
$$

Therefore, the only non-vanishing contribution for $\Lambda \rightarrow \infty$ comes from the diagram $D$, leading to

$$
\begin{equation*}
\widetilde{\mathcal{F}}_{2}^{\text {last }}(\kappa)=\widetilde{\mathcal{D}}(1+\kappa)-\widetilde{\mathcal{D}}(1) \tag{114}
\end{equation*}
$$

Remark: We see that Eq. (111) is consistent with the condition Eq. (71). Moreover, we shall see that the integrals in Eq. (112a) and Eq. (114) converge in the $\Lambda \rightarrow \infty$ limit, as one would expect for our theory to be correct.

Remark: Note that in Eq. (107) the contribution from diffusion constant $D$ in Eq. (14) is constant, which cancels in Eq. (111). This is expected as the distribution of $t_{\text {last }}$ is independent of the diffusion constant, whereas as a distribution involving space would depend on $D$. The same applies for the distribution of $t_{\text {max }}$ and $t_{\mathrm{pos}}$.

For the leading-order term Eq. (112a), explicitly carrying out the integral in Eq. (90) in the limit of $\Lambda \rightarrow \infty$, we get

whose $\mathcal{K}^{-1}$-transformation is (see Eq. (F4))

\mathcal{K}_{\kappa \rightarrow \vartheta}^{-1} \odot \widetilde{\mathcal{F}}_{1}^{\text {last }}(\kappa)=-\ln \frac{\vartheta}{(1-\vartheta)}=-\mathcal{R}^{\text {last }}(\vartheta) \tag{116}
\end{equation*}
$$

Using the result Eq. (69b) for $t_{\text {last }}$ gives the leading-order result in Eq. (40a).

For the second-order term in Eq. (69c) we use Eq. (114), Eq. (40a), and

\end{equation*}

(using the identity Eq. (F5)) to write

$$
\begin{equation*}
\mathcal{F}_{2}^{\text {last }}(\vartheta)=\mathcal{K}_{\kappa \rightarrow \vartheta}^{-1} \odot[\widetilde{\mathcal{D}}(1+\kappa)-\widetilde{\mathcal{D}}(1)]-\frac{\pi^{2}}{2} \tag{118}
\end{equation*}
$$

where we use linearity of the operator $\mathcal{K}^{-1}$.
The integral for $\widetilde{\mathcal{D}}(z)$ in Eq. (98) is convergent in the limit of $\Lambda \rightarrow \infty$, but it is hard to evaluate analytically. The expression for $\mathcal{F}_{2}^{\text {last }}(\vartheta)$ in Eq. (41) is obtained [76] by exchanging the order of $\mathcal{K}_{\kappa \rightarrow \vartheta}^{-1}$ transformation and the $y$-integrals in Eqs. (118) and (98). (For several other examples like in Eqs. (112a) and (116) where integration can be explicitly carried out, we have verified that this exchange of order gives the correct result.) The resulting function $\mathcal{F}_{2}^{\text {last }}(\vartheta)$ in Eq. (41) is plotted in Fig. 15 along with a polynomial estimation given in Eq. (42). The expression Eq. (41) is in good agreement with our computer simulation result in Fig. 7.

## VII. DISTRIBUTION OF THE TIME $t_{\text {max }}$ WHEN THE FBM ATTAINS MAXIMUM

The probability for an fBm , starting at $X_{0}=0$ and evolving till time $T$, to attain its maximum at time $t_{\max }=\tau$ can be expressed as

P_{T}\left(t_{\max }=\tau\right)=\frac{W(\tau, T)}{N(T)} \tag{119}
\end{equation*}
$$

Here $W(\tau, T)$ is the weight of all contributing trajectories, and $N(T)$ is the corresponding normalization. We use the same notations as in Sec. VI. Note, however, that the definition of these quantities ( $W, N$, etc.) is specific to the problem in this section.

Noting the symmetry of the problem (illustrated in Fig. 16), we write

W(\tau, T)=\int_{0}^{\infty} & d m_{1} \int_{0}^{\infty} d m_{2} \int_{x(0)=m_{1}}^{x(T)=m_{2}} \mathcal{D}[x] \\
& \times \delta\left(x(\tau)-x_{0}\right) \prod_{t=0}^{T} \Theta[x(t)] e^{-S[x]} \tag{120}
\end{align*}
$$

The probability density $P_{T}(\tau)$ in Eq. (119) is obtained by taking the limit of $x_{0} \rightarrow 0$. (Like in the previous section, we do not write any explicit reference to $x_{0}$, unless necessary.)

The perturbation expansion Eq. (7) of the fBm action $S$ leads to an expansion of $W$ similar to Eq. (75) with

\begin{align*}
W_{0}(\tau, T) & =\int_{0}^{\infty} d m_{1} \int_{0}^{\infty} d m_{2}\left\langle\langle 1\rangle\left(m_{1}, m_{2}\right)\right.  \tag{121}\\
W_{1}(\tau, T) & =\int_{0}^{\infty} d m_{1} \int_{0}^{\infty} d m_{2}\left\langle\left\langle\frac{S_{1}}{2 D}\right\rangle\right\rangle_{\left(m_{1}, m_{2}\right)}  \tag{122}\\
W_{2}(\tau, T) & =\int_{0}^{\infty} d m_{1} \int_{0}^{\infty} d m_{2}\left\langle\left\langle\frac{S_{1}^{2}}{8 D^{2}}-\frac{S_{2}}{D}\right\rangle\right\rangle_{\left(m_{1}, m_{2}\right)} \tag{123}
\end{align*}
$$

By the double-angular brackets we denote

$$
\begin{align*}
& \langle O[x]\rangle_{\left(m_{1}, m_{2}\right)}  \tag{124}\\
& :=\int_{x(0)=m_{1}}^{x(T)=m_{2}} \mathcal{D}[x] \delta\left(x(\tau)-x_{0}\right) \prod_{t=0}^{T} \Theta[x(t)] e^{-\frac{S_{0}}{D}} O[x(t)] .
\end{align*}
$$

Here, both $m_{1} \geq 0$ and $m_{2} \geq 0$, and the average is over trajectories sketched in Fig. 16 with the standard Brownian measure. Note that this definition is different from the one in Eq. (79), due to the different boundary conditions employed there. We will now in turn study averages at different orders, expressed in terms of the Brownian propagator Eq. (80) in presence of an absorbing wall. This is similar to the analysis of $t_{\text {last }}$ in the previous Sec. VI.

## A. Zeroth order

Similar to Eq. (83), we write the double Laplace transformation of Eq. (121) as

Using Eq. (84) and integrating, it is easy to see that for small $x_{0}$,

\end{equation*}
$$

The leading non-vanishing term is of order $x_{0}^{2}$, and its amplitude is same as in Eq. (85). This gives the well-known arcsinelaw (4) for $t_{\text {max }}$.

## B. Linear order: 1-loop diagrams

Similar to Eq. (88a) we write $W_{1}$ in Eq. (122) in three parts according to the order of $\left(r_{1}, r_{2}, \tau\right)$. Their diagrammatic representation is similar to the 1-loop diagrams in Fig. 11, but their amplitude is different. They are given by

A_{2}(\tau, T)= & \frac{1}{2 D} \int_{0}^{\infty} d m_{1} d m_{2} \int_{0}^{\Lambda} d y \\
& \times Z_{\tau}^{+}\left(m_{1}, x_{0}\right) J_{T-\tau}^{+}\left(x_{0}, m_{2} ;-y, y\right)  \tag{126b}\\
A_{3}(\tau, T)= & \frac{1}{2 D} \int_{0}^{\infty} d m_{1} d m_{2} \int_{0}^{\Lambda} d y \\
\times & J_{\tau}^{+}\left(m_{1}, x_{0} ;-y\right) J_{T-\tau}^{+}\left(x_{0}, m_{2} ; y\right) e^{-y \tau} \tag{126c}
\end{align*}
$$

The function $J_{t}^{+}$is the counterpart of Eq. (89) in presence of an absorbing wall at the origin. Their double Laplace transform Eq. (60) gives

\widetilde{A}_{1}(\lambda, s)= & \frac{1}{2 D} \int_{0}^{\infty} d m_{1} d m_{2} \int_{0}^{\Lambda} d y \\
& \times \widetilde{J}_{s+\lambda}^{+}\left(m_{1}, x_{0} ;-y, y\right) \widetilde{Z}_{s}^{+}\left(x_{0}, m_{2}\right)  \tag{127a}\\
\widetilde{A}_{2}(\lambda, s)= & \frac{1}{2 D} \int_{0}^{\infty} d m_{1} d m_{2} \int_{0}^{\Lambda} d y \\
& \times \widetilde{Z}_{s+\lambda}^{+}\left(m_{1}, x_{0}\right) \widetilde{J}_{s}^{+}\left(x_{0}, m_{2} ;-y, y\right)  \tag{127b}\\
\widetilde{A}_{3}(\lambda, s)= & \frac{1}{2 D} \int_{0}^{\infty} d m_{1} d m_{2} \int_{0}^{\Lambda} d y \\
& \times \widetilde{J}_{s+\lambda+y}^{+}\left(m_{1}, x_{0} ;-y\right) \widetilde{J}_{s}^{+}\left(x_{0}, m_{2} ; y\right) \tag{127c}
\end{align*}
$$

These integrals can be evaluated explicitly using the results in Apps. L and N, specifically Eqs. (G3), (L5), and their symmetry properties for evaluating Eqs. (127a), (127b), as well as

Eqs. (N6) and (N7) for evaluating Eq. (127c). For small $x_{0}$, we get

& \widetilde{A}_{2}(s \kappa, s) \simeq \frac{x_{0}^{2}}{D s} \times \frac{\widetilde{\mathcal{A}}(1)}{\sqrt{1+\kappa}}  \tag{129}\\
& \widetilde{A}_{3}(s \kappa, s) \simeq \frac{x_{0}^{2}}{D s} \times \frac{\widetilde{\mathcal{A}_{3}}(1+\kappa)}{\sqrt{1+\kappa}} \tag{130}
\end{align*}
$$

with $\widetilde{\mathcal{A}}(z)$ defined in Eq. (90) and

$$
\begin{equation*}
\widetilde{\mathcal{A}_{3}}(z)=-2 \int_{0}^{\Lambda / s} \frac{d y}{y^{2}}(\sqrt{z+y}-\sqrt{z})(\sqrt{1+y}-1) \tag{131}
\end{equation*}
$$

Summing all three contributions we get the double Laplace transform Eq. (60) of the linear-order term $W_{1}(\tau, T)$ in Eq. (122). It reads, for small $x_{0}$,

\end{equation*}
$$

We note the simplification

& \widetilde{\mathcal{A}}(z)+\widetilde{\mathcal{A}}(1)+\widetilde{\mathcal{A}_{3}}(z) \\
& \quad=\int_{0}^{\Lambda / s} \frac{d y}{y^{2}}[(\sqrt{z+y}-\sqrt{z})-(\sqrt{1+y}-1)]^{2} \tag{133}
\end{align*}
$$

## C. Quadratic order

Similar to Eq. (96), we find that the second-order term $W_{2}$ in Eq. (123) is composed of the 2-loop diagrams in Fig. 14. The amplitudes of these diagrams are different for this problem. Here we summarize their result for small $x_{0}$. Their derivation is given in App. H .

The list below contains the double Laplace transform of all 2-loop diagrams. All amplitudes are of order $x_{0}^{2}$ for small $x_{0}$. Note that many diagrams are the same as in the problem of $t_{\text {last }}$ in Sec. VI; this may not be surprising as the same powerlaw corrections for $\vartheta \rightarrow 0$ and $\vartheta \rightarrow 1$ are also present in the distribution of $t_{\text {last }}$.

The list of already calculated diagrams reads ( $x_{0} \ll 1$ ):

\widetilde{A}(s \kappa, s) \simeq \frac{x_{0}^{2}}{s D} \times \frac{\widetilde{\mathcal{A}}(1+\kappa) \widetilde{\mathcal{A}}(1)}{\sqrt{1+\kappa}} \tag{135}
\end{equation*}
$$

with $\widetilde{\mathcal{A}}(z)$ given in Eq. (90).

$$
\begin{equation*}
\widetilde{G}_{1}(s \kappa, s)+\widetilde{G}_{2}(s \kappa, s) \simeq \frac{x_{0}^{2}}{s D} \times \frac{\widetilde{\mathcal{G}}(1+\kappa)+\widetilde{\mathcal{G}}(1)}{\sqrt{1+\kappa}} \tag{136}
\end{equation*}
$$

with $\widetilde{\mathcal{G}}(z)$ given in Eq. (104).
The amplitudes of the remaining diagrams are different. We get, for small $x_{0}$,

\widetilde{D}(s \kappa, s)=\frac{x_{0}^{2}}{s D} \times \frac{\widetilde{\mathcal{D}}(1+\kappa)}{\sqrt{1+\kappa}} \tag{137}
\end{equation*}

\widetilde{\mathcal{D}}(z)= & 2 \int_{0}^{\Lambda / s} \frac{d y_{1} d y_{2}}{y_{1}^{2} y_{2}^{2}} \sqrt{z+y_{1}+y_{2}} \sqrt{1+y_{1}+y_{2}} \\
& \times\left(\sqrt{1+y_{1}+y_{2}}-\sqrt{1+y_{1}}-\sqrt{1+y_{2}}+1\right) \\
& \times\left(\sqrt{z+y_{1}+y_{2}}-\sqrt{z+y_{1}}-\sqrt{z+y_{2}}+\sqrt{z}\right) . \tag{138}

The difference to Eq. (98) is in the first term inside the integrals and the overall sign.

The leading non-vanishing amplitudes of diagrams $B$ and $C$ are of order $x_{0}^{2}$, and unlike in Sec. VI, these diagrams are relevant here. Their Laplace transform, for small $x_{0}$ are

and

\widetilde{C}_{1}(s \kappa, s)+\widetilde{C}_{2}(s \kappa, s) \simeq \frac{x_{0}^{2}}{s} \times \frac{(\widetilde{\mathcal{C}}(1,1+\kappa)+\widetilde{\mathcal{C}}(1+\kappa, 1))}{D \sqrt{1+\kappa}} \tag{141}
\end{equation*}
$$

where

\begin{align*}
& \widetilde{\mathcal{C}}\left(z_{1}, z_{2}\right)=2 \int_{0}^{\Lambda / s} \frac{d y_{1} d y_{2}}{y_{1}^{2} y_{2}^{2}}\left(\sqrt{z_{1}}-\sqrt{z_{1}+y_{1}}\right) \sqrt{z_{2}+y_{1}} \\
& \quad \times\left(\sqrt{z_{2}+y_{1}+y_{2}}-\sqrt{z_{2}+y_{1}}-\sqrt{z_{2}+y_{2}}+\sqrt{z_{2}}\right)^{2} \tag{142}
\end{align*}
$$

From the amplitude of all 2-loop diagrams in Eq. (96) we get the double Laplace transform of $W_{2}(\tau, T)$ in Eq. (123), for small $x_{0}$,

& +\widetilde{\mathcal{B}}(1+\kappa)+\widetilde{\mathcal{G}}(1+\kappa)+\widetilde{\mathcal{G}}(1)] \tag{143}
\end{align*}

## D. Result for $\mathcal{F}^{\text {max }}(\kappa, H)$

Taking the results in Eqs. (125), (132), (143), and the expansion (14) we write in an exponential form analogous to Eq. (106), where, for this problem,

\widetilde{\mathcal{W}}_{2}(\kappa)= & {[\widetilde{\mathcal{E}}(1+\kappa)+\widetilde{\mathcal{E}}(1)+\widetilde{\mathcal{A}}(1+\kappa) \widetilde{\mathcal{A}}(1)+\widetilde{\mathcal{D}}(1+\kappa)} \\
& +\widetilde{\mathcal{C}}(1,1+\kappa)+\widetilde{\mathcal{C}}(1+\kappa, 1)+\widetilde{\mathcal{B}}(1+\kappa) \\
& +\widetilde{\mathcal{G}}(1+\kappa)+\widetilde{\mathcal{G}}(1)]-\frac{1}{2}[\widetilde{\mathcal{A}}(1+\kappa)+\widetilde{\mathcal{A}}(1) \\
& \left.+\widetilde{\mathcal{A}_{3}}(1+\kappa)\right]^{2}+2\left(1-\frac{\pi^{2}}{6}\right)
\end{aligned}
$$

The rest of the analysis is very similar to that in Sec. VID. To leading order we get

Explicitly carrying out the integral in the $\Lambda \rightarrow \infty$ limit yields

& \widetilde{\mathcal{F}}_{1}^{\max }(\kappa)=-8 \ln 2-(1+\sqrt{1+\kappa}) \ln (1+\kappa) \\
& \quad+\frac{2}{\sqrt{1+\kappa}}(1+\sqrt{1+\kappa})^{2} \ln (1+\sqrt{1+\kappa}) \tag{145}
\end{align*}
$$

Its inverse transform Eq. (68) is (see Eq. (F8))

$$
\begin{align*}
\mathcal{K}_{\kappa \rightarrow \vartheta}^{-1} \odot \widetilde{\mathcal{F}}_{1}^{\max }(\kappa)= & -8 \ln 2+\psi\left(\sqrt{\frac{\vartheta}{1-\vartheta}}\right) \\
& -\ln (\vartheta(1-\vartheta)) \tag{146}
\end{align*}
$$

with $\psi(x)$ defined in Eq. (40c). Then Eq. (69b) with $\mathcal{R}^{\max }(\vartheta)=\ln (\vartheta(1-\vartheta))$ gives the leading-order term

The expression in Eq. (147) differs from Eq. (40b) by a constant, which comes from our convention that for the latter the integral over $\vartheta$ vanishes.

At second order, we get

=\left[\widetilde{\mathcal{D}}(1+\kappa)-\frac{1}{2} \widetilde{\mathcal{A}_{3}}(1+\kappa)^{2}-\left(\widetilde{\mathcal{D}}(1)-\frac{1}{2} \widetilde{\mathcal{A}_{3}}(1)^{2}\right)\right] \\
+[\widetilde{\mathcal{B}}(1+\kappa)+\widetilde{\mathcal{C}}(1,1+\kappa)+\widetilde{\mathcal{C}}(1+\kappa, 1) \\
\quad-\widetilde{\mathcal{A}_{3}}(1+\kappa)(\widetilde{\mathcal{A}}(1+\kappa)+\widetilde{\mathcal{A}}(1)) \\
\left.\quad-\left(\widetilde{\mathcal{B}}(1)+2 \widetilde{\mathcal{C}}(1,1)-2 \widetilde{\mathcal{A}_{3}}(1) \widetilde{\mathcal{A}}(1)\right)\right] \\
\quad+\left[\widetilde{\mathcal{E}}(1+\kappa)+\widetilde{\mathcal{G}}(1+\kappa)-\frac{1}{2} \widetilde{\mathcal{A}}^{2}(1+\kappa)\right. \\
\left.\quad-\left(\widetilde{\mathcal{E}}(1)+\widetilde{\mathcal{G}}(1)-\frac{1}{2} \widetilde{\mathcal{A}}^{2}(1)\right)\right] . \tag{148}
\end{gather*}
$$

The terms are written such that each square bracket remains finite for $\Lambda \rightarrow \infty$ limit. In fact, we see that the expression in the last square bracket is same as in Eq. (112b) and it vanishes for $\Lambda \rightarrow \infty$. Rest two square brackets give $\widetilde{\mathcal{F}}_{2}^{\max }(\kappa)$ for the $\Lambda \rightarrow \infty$.

Remark: We see that for $\kappa=0$, both $\widetilde{\mathcal{F}}_{1}^{\max }(\kappa)$ and $\widetilde{\mathcal{F}}_{2}^{\max }(\kappa)$ vanish, which is consistent with the condition (71).

From Eq. (69c) and using linearity of the transformation $\mathcal{K}_{\kappa \rightarrow \vartheta}^{-1}$ we write

\end{align*}

Using an identity Eq. (F9) we see that

where we define

& -\left[2 \arctan \frac{1}{x}+\frac{1}{x} \ln \left(1+x^{2}\right)\right] \tag{151}

This leads to our result

\end{equation*}
$$

(We note that the last term is symmetric in $\vartheta \rightarrow 1-\vartheta$.)

It is hard to analytically evaluate the integrals in Eq. (148). Similar to Eq. (118), we determine $\mathcal{F}_{2}^{\max }(\vartheta)$ by exchanging the order of $\mathcal{K}$-transformation and integration. This gives, up to an additive constant,

& \quad+2 \int_{0}^{\infty} \frac{d y_{1} d y_{2}}{y_{1}^{2} y_{2}^{2}} \Psi^{\max }\left(y_{1}, y_{2}, \frac{1-\vartheta}{\vartheta}\right) \tag{153}
\end{align*}
$$

where $\Psi^{\max }\left(y_{1}, y_{2}, z\right)$ has a lengthy expression given in the Appendix I. The expression is also given in the supplemental Mathematica notebook [76] for numerical evaluation.

Our result for $\mathcal{F}_{2}^{\max }(\vartheta)$ in Eq. (152) is plotted in Fig. 17, which agrees well with our computer simulation result in Fig. 7. For this, we evaluated both the $\mathcal{K}^{-1}$-transformation and the $y$-integration numerically.

## VIII. DISTRIBUTION OF TIME $t_{\text {pos }}$ WHERE THE PROCESS IS POSITIVE

This analysis is more involved compared to the analysis for $t_{\text {last }}$ and $t_{\text {max }}$. The main reason is that the expressions at second order are very cumbersome, and a lot of ingeniosity is needed to reduce them to a manageable size.

Analogous to Eq. (119), the probability that an fBm , starting at $X_{0}=0$ and evolving until time $T$, spends time $t_{\text {pos }}=\tau$ being positive $\left(X_{t}>0\right)$, can be expressed as

\end{equation*}
$$

where $W(\tau, T)$ is the weight of all fBm trajectories contributing to the event and $N(T)$ its normalization. Formally,
$W(\tau, T)=\int_{-\infty}^{\infty} d m \int_{x(0)=0}^{x(T)=m} \mathcal{D}[x] \delta\left(\tau-\int_{0}^{T} d t \Theta(x(t))\right) e^{-S[x]}$,
where $\Theta(x)$ is the Heaviside step function. A sketch of such a trajectory is given in Fig. 18. We follow the same notations

as in sections VI and VII. The definition of the quantities $W$, $N$, etc., is modified to measure the positive time.

Using the perturbation expansion of the fBm action in Eq. (7) we write (75), with

& W_{2}(\tau, T)=\int_{-\infty}^{\infty} d m\left\langle\left\langle\frac{S_{1}^{2}}{8 D^{2}}-\frac{S_{2}}{D}\right\rangle\right\rangle_{(0, m)} \tag{156c}
\end{align*}
$$

where the double-angular brackets denote

& :=\int_{x(0)=m_{1}}^{x(T)=m_{2}} \mathcal{D}[x] \delta\left(\tau-\int_{0}^{T} d t \Theta(x(t))\right) e^{-\frac{S_{0}}{D}} O[x(t)] .
\end{align*}
$$

This is an average over trajectories with Brownian measure.

## A. Conditional propagator

In Sec. VI and Sec. VII, the amplitudes in the expansion (75) are expressed in terms of the free Brownian propagator $Z$ in Eq. (23) and its analogue $Z^{+}$in presence of an absorbing wall. For amplitudes (156), it is natural to express in terms of a conditional Brownian propagator, defined by

\end{equation*}

This gives the weight of all Brownian paths starting at $m_{1}$ and ending at $m_{2}$ at time $T$ conditioned to spending time $\tau$ on the positive half.

To find an explicit expression for the conditional propagator, we write the associated paths into two groups,

shown in the Fig. 19. The term $\mathbb{A}$ is non-zero only for $\tau=0$
or $T$. Using Eq. (80), we write

&+\Theta\left(-m_{1}\right) \Theta\left(-m_{2}\right) \delta(\tau) Z_{T}^{+}\left(-m_{1},-m_{2}\right)
\end{aligned}
$$

Its double Laplace transform can be written with the help of identity (86) as

& +\Theta\left(-m_{1}\right) \Theta\left(-m_{2}\right) \widetilde{Z}_{s}^{+}\left(-m_{1},-m_{2}\right)
\end{align*}
$$

where expression (84) leads to

& \widetilde{\mathbb{A}}_{s}\left(m_{1}, m_{2} \mid \lambda\right)=\frac{\Theta\left(m_{1} m_{2}\right)}{2 \sqrt{D\left(s+\lambda \Theta\left(m_{1}\right)\right)}}  \tag{161}\\
& \quad \times\left[e^{\left.-\left|m_{1}-m_{2}\right| \sqrt{\frac{s+\lambda \Theta\left(m_{1}\right)}{D}}-e^{-\left|m_{1}+m_{2}\right| \sqrt{\frac{s+\lambda \Theta\left(m_{1}\right)}{D}}}\right]} .\right.
\end{align*}
$$

The second part of Eq. (159) is defined by (see Fig. 19)

\mathbb{B}_{T}\left(m_{1}, m_{2} \mid \tau\right)=\int_{0}^{T} d t_{1} \int_{t_{1}}^{T} d t_{2}\left\langle\delta\left(x\left(t_{1}\right)\right) \delta\left(x\left(t_{2}\right)\right)\right\rangle\left(m_{1}, m_{2}\right) \tag{162}
\end{equation*}
$$

with $\tau$ specified in the average (157). One can estimate, for example, for $m_{1}>0$ and $m_{2}>0$,

& \times \mathscr{G}\left(\tau-t_{1}-t_{2}, T-t_{1}-t_{2}\right) \times\left[\lim _{x_{0} \rightarrow 0} \frac{Z_{t_{2}}^{+}\left(x_{0}, m_{2}\right)}{x_{0}}\right], \tag{163}
\end{align*}
$$

(here $D^{2}$ is from dimensional argument) up to a normalization $\mathcal{N}$, where $\mathscr{G}(\tau, T)$ is the weight of Brownian paths starting at the origin and returning there at time $T$, spending time $\tau$ in the positive half.

In general, using identity (86), we write the double Laplace transform of $\mathbb{B}$ as

& \widetilde{\mathbb{B}}_{s}\left(m_{1}, m_{2} \mid \lambda\right)=\mathcal{N} D^{2} \tilde{\mathscr{G}}(\lambda, s) \\
& \times\left[\lim _{x_{0} \rightarrow 0} \frac{\Theta\left(m_{1}\right) \widetilde{Z}_{s+\lambda}^{+}\left(m_{1}, x_{0}\right)+\Theta\left(-m_{1}\right) \widetilde{Z}_{s}^{+}\left(-m_{1}, x_{0}\right)}{x_{0}}\right] \\
& \times\left[\lim _{x_{0} \rightarrow 0} \frac{\Theta\left(m_{2}\right) \widetilde{Z}_{s+\lambda}^{+}\left(x_{0}, m_{2}\right)+\Theta\left(-m_{2}\right) \widetilde{Z}_{s}^{+}\left(x_{0},-m_{2}\right)}{x_{0}}\right],
\end{aligned}
$$

The normalization $\mathcal{N}$ to be determined self-consistently, and $\widetilde{\mathscr{G}}(\lambda, s)$ is the double Laplace transform of $\mathscr{G}(\tau, T)$.

We see that

\mathscr{G}(\tau, T)=Z_{T}(0,0) P_{\text {bridge }}(\tau, T)
$$

where $P_{\text {bridge }}(\tau, T)$ is the probability of positive time $t_{\text {pos }}=$ $\tau$ for a Brownian bridge of duration $T$. One can show
(a derivation is given in App. Q) that for a Brownian bridge, all values of $\tau$ are equally probable, and therefore $P_{\text {bridge }}(\tau, T)=1 / T$. This, along with Eq. (23), gives

\widetilde{\mathscr{G}}(\lambda, s)=\frac{\sqrt{s+\lambda}-\sqrt{s}}{\lambda \sqrt{D}}
$$

Using these results and Eq. (84), we find

\times & {\left[\frac{\sqrt{s+\lambda}-\sqrt{s}}{\lambda \sqrt{D}}\right] e^{-\left|m_{2}\right| \sqrt{\frac{s+\Theta\left(m_{2}\right) \lambda}{D}}}, }
\end{align*}
$$

where we used $\mathscr{N}=1$, determined using the self-consistency condition that

\int_{0}^{T} d \tau \mathbb{Z}_{T}\left(m_{1}, m_{2} \mid \tau\right)=Z_{T}\left(m_{1}, m_{2}\right) \tag{165}
\end{equation*}

for Eq. (159), and equivalently,

\widetilde{\mathbb{Z}}_{s}\left(m_{1}, m_{2} \mid 0\right)=\widetilde{Z}_{s}\left(m_{1}, m_{2}\right)=\frac{e^{-\sqrt{\frac{s}{D}}\left|m_{1}-m_{2}\right|}}{2 \sqrt{s D}}
$$

where $\widetilde{\mathbb{Z}}_{s}\left(m_{1}, m_{2} \mid \lambda\right)$ is the Double Laplace transformation Eq. (60) of $\mathbb{Z}_{T}\left(m_{1}, m_{2} \mid \tau\right)$. Results (161) and (164) together give

\widetilde{\mathbb{Z}}_{s}\left(m_{1}, m_{2} \mid \lambda\right)=\widetilde{\mathbb{A}}_{s}\left(m_{1}, m_{2} \mid \lambda\right)+\widetilde{\mathbb{B}}_{s}\left(m_{1}, m_{2} \mid \lambda\right) \tag{166}
\end{equation*}
$$

This will be used extensively in the following sections.

## B. Zeroth order term

The leading term (156a) is

W_{0}(\tau, T)=\int_{-\infty}^{\infty} d m \mathbb{Z}_{T}(0, m \mid \tau)
$$

Its double Laplace transform is

\widetilde{W}_{0}(\lambda, s)=\int_{-\infty}^{\infty} d m \widetilde{\mathbb{Z}}_{s}(0, m \mid \lambda)
$$

with $\widetilde{\mathbb{Z}}$ in Eq. (166).
The integration can be evaluated using Eq. (166) with $\widetilde{\mathbb{A}}$ and $\widetilde{\mathbb{B}}$ given in Eqs. (161) and (164). The result is given in Eq. (P3) using which we write

\widetilde{W}_{0}(s \kappa, s)=\frac{1}{s} \times \frac{1}{\sqrt{1+\kappa}} \tag{167}
\end{equation*}

This is same as for distribution of $t_{\text {last }}$ and $t_{\text {max }}$, and confirms the arcsine-law (4).

## C. Linear order: 1-loop diagram

Using Eq. (10a) we write the linear order term (156b) as

\end{align*}

where the integral over time $r$ is interpreted as in Eq. (15). A graphical representation of the amplitude as a 1-loop diagram is sketched in Fig. 20.

To evaluate the conditional average in Eq. (168) we use a result for the correlation similar to Eq. (M4). Generalizing the analysis in App. M for the conditioned case, we see that for $r_{2}>r_{1}$,

& \times \int_{0}^{T-r_{2}} d \tau_{3} \delta\left(\tau-\tau_{1}-\tau_{2}-\tau_{3}\right) \int_{-\infty}^{\infty} d x_{1} d x_{2} \mathbb{Z}_{r_{1}}\left(m_{1}, x_{1} \mid \tau_{1}\right) \\
& \quad \partial_{x_{1}} \mathbb{Z}_{r_{2}-r_{1}}\left(x_{1}, x_{2} \mid \tau_{2}\right) \partial_{x_{2}} \mathbb{Z}_{T-r_{2}}\left(x_{2}, m_{2} \mid \tau_{3}\right) . \tag{169}
\end{align*}
$$

This helps us to write $W_{1}(\tau, T)$ in terms of the conditional propagator $\mathbb{Z}$. By a change of variables and an integration by parts we obtain

& \times \delta\left(T-t_{1}-t_{2}-t_{3}\right) \delta\left(\tau-\tau_{1}-\tau_{2}-\tau_{3}\right) \int_{0}^{\Lambda} d y e^{-y t_{2}} \int_{-\infty}^{\infty} d m \\
& \times \int_{-\infty}^{\infty} d x_{1} d x_{2} \partial_{x_{1}} \mathbb{Z}_{t_{1}}\left(0, x_{1} \mid \tau_{1}\right) \mathbb{Z}_{t_{2}}\left(x_{1}, x_{2} \mid \tau_{2}\right) \\
& \quad \times \partial_{x_{2}} \mathbb{Z}_{t_{3}}\left(x_{2}, m \mid \tau_{3}\right) \tag{170}
\end{align*}
$$

A double Laplace transform Eq. (60) of the amplitude gives

\times \widetilde{\mathbb{Z}}_{s+y}\left(x_{1}, x_{2} \mid \lambda\right) \int_{-\infty}^{\infty} d m \partial_{x_{2}} \widetilde{\mathbb{Z}}_{s}\left(x_{2}, m \mid \lambda\right) \tag{171}
\end{gather*}
$$

with $\widetilde{\mathbb{Z}}$ defined in Eq. (166).
Using the result (166) and integrating using integrals (P7), (P8), we get

## D. Quadratic order: 2-loop diagrams

Following an analysis similar to that in Sec. VIC, it is straightforward to see that for $W_{2}$ in Eq. (156c) contributions come only from the two diagrams shown in Fig. 21,

(159), and then an explicit result can be derived following an analysis similar to that of the linear-order term in Sec. VIII C. ## E. Result for $\mathcal{F}^{\text {pos }}(\kappa, H)$

Rest of the analysis is very similar to that for $t_{\text {last }}$ and $t_{\text {max }}$. We write the amplitude $\widetilde{W}(\lambda, s)$ in Eq. (155) in an exponential form such that

It is difficult to analytically do the integration for the amplitudes in the second term in Eq. (190). We have numerically verified that the term remains finite for $\Lambda \rightarrow \infty$. For an explicit formula in terms of $\vartheta$ we exchange the order of $\mathcal{K}_{\kappa \rightarrow \vartheta^{-}}^{-1}$ transformation and the integration. This allows us to write

Expression for $\Psi^{\mathrm{pos}}$ is lengthy and it is given in the Appendix K. Our result for $\mathcal{F}_{2}^{\text {pos }}(\vartheta)$ is plotted in Fig. 7, which agrees well with our computer simulation result. For this we evaluated both the $\mathcal{K}^{-1}$-transformation and the $y$-integration numerically.

## IX. SUMMARY

We found a generalization of the three arc-sine laws of Brownian motion for an fBm . Unlike in the Brownian motion, the probabilities are different and given in Eqs. (38)(37). These results are obtained using a perturbation expansion around the Brownian motion, and by a scaling argument for divergences near $\vartheta \rightarrow 0$ and 1 . Our numerical simulations confirm these highly non-trivial predictions accurately. We find a very good convergence to the numerical results for the entire range of $\vartheta$ even for large $\varepsilon$. Most realizations of fBm found in practical applications fall within the range $H \simeq \frac{1}{2} \pm 0.25$ where our formulas yield high-precision predictions.

Our perturbation approach offers a systematic framework to obtain analytical results for other observables of an fBm , of which very few are available so far. For example, distribution of Area under a Brownian excursion is known to have an Airy distribution [77]. Corresponding generalization for an fBm is yet unavailable. On simpler examples, a closed form expression for an fBm propagator with absorbing and reflecting boundary is desirable.

& C\left(t_{1}, t_{2}\right)=2 \widehat{D}\left[\delta\left(t_{1}-t_{2}\right)+\varepsilon \frac{1}{\left|t_{1}-t_{2}\right|}\right. \\
&\left.+\varepsilon^{2} \frac{2 \ln \frac{\mid t_{1}-t_{2}}{\omega}}{\left|t_{1}-t_{2}\right|}+\cdots\right] \tag{B3}
\end{align*}
$$

with $\widehat{D}=2 H \omega^{2 H-1}=(1+2 \varepsilon) \omega^{2 \varepsilon}$, and $\omega$ being an ultraviolet cutoff in time. This implies

Substituting in Eq. (B1) and defining a normal-ordered form (non-contact terms only) in Eq. (16) we get

with $D$ given in Eq. (9). Comparing with Eqs. (7)-(8) one can see that the both leading and sub-leading terms are same whereas the $\varepsilon^{2}$ order term includes only contact-less terms. An integral representation of the normal-ordered second-order term is in Eq. (17).

## Appendix C: The fBm propagator

Here, we verify Eq. (18) using the perturbation expansion of the action (A6) to all orders. In terms of this expansion, Eq. (20a) can be written as

Remark: In Eq. (C3), the contribution from terms like $K_{1} G_{0} K_{1}$ etc in Eq. (A5) are canceled from the terms in normalization $N_{T}$ in Eq. (18). One may explicitly verify this at lower orders in perturbation expansion.

Using Eq. (A1) in Eq. (C4), it is easy to see that

## Appendix D: Numerical simulation of an fBm

Efficient computer simulation of an fBm trajectory is a delicate task. A vast literature has been published on this subject. For a comparative study of many of the sampling methods for an fBm see the review [78] and references therein. In general these algorithms generate the full trajectory. If one is only interested in a specific observable, as the first-passage time, not all points need to be generated, allowing for tremendous gains both in memory usage and execution speed [66, 72, 73].

In our work, we use a discrete-time sampling method following the Davis and Harte procedure [70] (also known as the Wood and Chan procedure [79]) as described in Ref. [71]. The basic idea is to construct fBm paths from a discrete-time sampling of stationary, Gaussian-distributed, increments $\Delta X_{n}$ for integers $n=0,1, \cdots, N-1$, with mean $\left\langle\Delta X_{n}\right\rangle=0$ and covariance

for positive integers $n \leq m<N$. For large $N$ with $t=n / N$, one can see that $N^{2-2 \bar{H}} \gamma(N t-N s)$ converge to the covariance (2). This means, the cumulated sum $N^{-H} \sum_{i=0}^{n} \Delta X_{i}$ for large $N$ gives an fBm path $X_{t}$ with $X_{0}=0$ in a time window $[0,1]$.

The Davis and Harte procedure is an efficient algorithm for generating samples of $\Delta X_{n}$ with a computational efficiency $\mathcal{O}(N \ln N)$ (compared to $\mathcal{O}\left(N^{3}\right)$ for Choleski decomposition method [78]). The algorithm involves the following simple steps. We construct two linear arrays $\left\{W_{n}\right\}$ and $\left\{\lambda_{n}\right\}$ of length $2 N$ with index $n=0,1, \cdots, 2 N-1$. Elements of the first array are generated from a set of $2 N$ independent Gaussian random numbers $V_{0}, V_{1}, \cdots, V_{2 N-1}$, with $\left\langle V_{n}\right\rangle=0$ and $\left\langle V_{m} V_{n}\right\rangle=\delta_{m, n}$. We define

for $n=1, \cdots, N-1$, whereas

for $n=N+1, \cdots, 2 N-1$. This construction ensures that $\left\langle W_{n}\right\rangle=0$ and

Elements of the second array are defined by

for integers $0 \leq n \leq 2 N-1$, where $\Gamma_{k}=\gamma(k)$ for $0 \leq k \leq$ $N$ and $\Gamma_{k}=\gamma(2 N-k)$ for $N+1 \leq k \leq 2 N-1$ with covariance in Eq. (D1). This means,

for $0 \leq n \leq N-1$. In comparison, we shall see that the set of increments for $N \leq n \leq 2 N-1$ do not have the covariance (D1) and they are discarded.
It is simple to verify that this construction (D8) indeed generates Gaussian random numbers with covariance (D1). The simplest is to see that $\left\langle\Delta X_{n}\right\rangle=0$ from $\left\langle W_{n}\right\rangle=0$. Moreover, $X_{n}$ is a linear combination of Gaussian random variables $W_{n}$, and therefore it's distribution remains Gaussian. For the covariance, using Eq. (D8) we write

which includes all $0 \leq n \leq m \leq N-1$. For indices $\geq N$, such that $m-n>N$, the covariance is $\gamma(2 N-m+n)$, and therefore $\Delta X_{n}$ for $n \geq N$ are discarded.

The mathematics behind this algorithm is clearly explained in [71, 78]. It involves calculating square root of a positive matrix by embedding it in a circulant matrix. We shall not repeat the discussion this here. Reader may find details in [71, 78].

## Appendix E: A derivation of the inverse transform

The inverse transformation in Eq. (63) can be derived using complex analysis by writing Eq. (62) as

We list the following results for the integral of the propagators, which are frequently used in this paper. They can be numerically verified in Mathematica.

## Appendix M: Time-correlation of Brownian velocities

Here, we derive multi-time correlations of velocity $\dot{x}(t)$ for a standard Brownian motion with diffusivity $D$. The first moment is defined by

where the Brownian propagator $Z$ is in Eq. (23) and we use Eq. (8a) for small $\Delta t$. Writing

Remark: In presence of an absorbing wall, correlations have a very similar formula as in Eqs. (M3), (M4), (M6), and (M8), where one need to substitute the propagator $Z$ by $Z^{+}$. However, they can not be simplified like in Eqs. (M10-M12).

## Appendix Q: Uniform distribution of $t_{\text {pos }}$ for a Brownian Bridge

In Sec. VIII A we used a result that for a Brownian bridge, time spent on positive half has a uniform distribution. Here, we give a derivation of this result.

Our derivation is for a random walk of total $2 n$ steps on an infinite chain. The walker is conditioned to take equal number of positive and negative steps such that at the final step the walker returns to the starting point, which we choose to

be the origin. Continuous limit of the process is a Brownian bridge, and the distribution of positive time for the Random walk gives the distribution for Brownian bridge in the continuous limit.

For our derivation, we define a generating function

$$
\begin{equation*}
G(\kappa, \rho)=1+\sum_{n=1}^{\infty} \sum_{m=0}^{n} \kappa^{n} \rho^{m} \frac{1}{2^{2 n}} N(2 n, 2 m) \tag{Q1}
\end{equation*}
$$

where $(\kappa, \rho)$ are parameters and $N(2 n, 2 m)$ gives the total number of Random walk bridges of length $2 n$ with $2 m$ number of steps spent on the positive side of the chain (see illustration in Fig. 27).

We define a second generating function

$$
\begin{equation*}
g(\kappa)=\sum_{n=1}^{\infty} \frac{\kappa^{n}}{2^{2 n}} N^{+}(2 n) \tag{Q2}
\end{equation*}
$$

where $N^{+}(2 n)$ gives the number of random bridges that stay on the positive side of the chain for the entire duration $2 n$ (Random walk excursion. See illustration in Fig. 27).

Using method of images it is straightforward to show that

$$
\begin{equation*}
N^{+}(2 n)=\binom{2 n-2}{n-1}-\binom{2 n-2}{n}=\frac{(2 n-2)!}{n!(n-1)!} \tag{Q3}
\end{equation*}
$$

leading to

$$
\begin{equation*}
g(\kappa)=\frac{1}{2}(1-\sqrt{1-\kappa}) \tag{Q4}
\end{equation*}
$$

To calculate $G(\kappa, \rho)$ we use a relation

$$
\begin{align*}
G(\kappa, \rho)= & 1+[g(\kappa)+g(\kappa \rho)]+ \\
& {\left[g(\kappa)^{2}+2 g(\kappa) g(\kappa \rho)+g(\kappa \rho)^{2}\right]+} \\
& {\left[g(\kappa)^{3}+3 g(\kappa)^{2} g(\kappa \rho)+3 g(\kappa) g(\kappa \rho)^{2}+g(\kappa \rho)^{3}\right] } \\
& +\cdots, \tag{Q5}
\end{align*}
$$

which can be seen by the graphical illustration in Fig. 28. Completing the summation we get

$$
\begin{equation*}
G(\kappa, \rho)=\frac{1}{1-g(\kappa)-g(\kappa \rho)} \tag{Q6}
\end{equation*}
$$

Using the formula for $g(\kappa)$ in Eq. (Q2) we write

$$
\begin{equation*}
G(\kappa, \rho)=1+\sum_{n=1}^{\infty} \sum_{m=0}^{n} \kappa^{n} \rho^{m} \frac{(2 n)!}{2^{2 n}(n+1)(n!)^{2}} \tag{Q7}
\end{equation*}
$$

Comparing with Eq. (Q1) it is evident that $N(2 n, 2 m)$ is independent of $m$. Equivalently, there are equal number of paths for all values of $m$ in a random walk bridge of length $2 n$. In the continuous limit, this means that for a Brownian bridge, all values of fractional positive time are equally probable.
